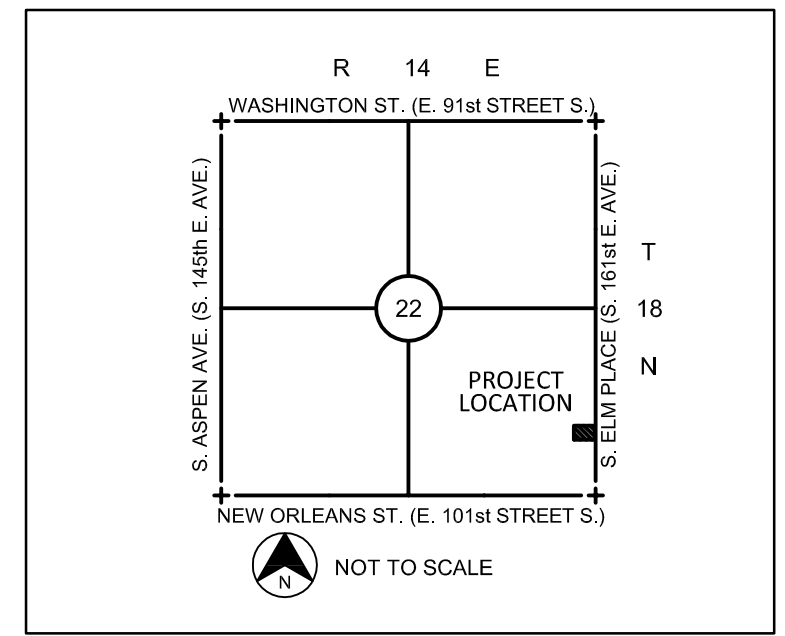
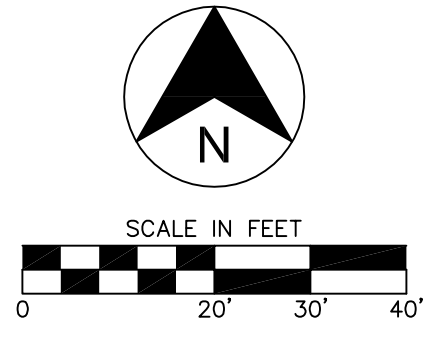


NOTE: CONTRACTOR SHALL SOD ALL DISTURBED AREAS.

GENERAL NOTES:

- 1. ALL DIMENSIONS AT CURBS ARE TO FACE OF CURB UNLESS OTHERWISE NOTED.
2. PROPOSED UTILITIES ARE SHOWN IN SCHEMATIC ONLY. EXACT LOCATIONS SHALL BE DETERMINED TO ALLOW FOR THE MOST ECONOMICAL AND PRACTICAL INSTALLATION.
3. THE CONTRACTOR SHALL COORDINATE WITH ALL UTILITY COMPANIES TO DETERMINE EXACT POINT OF SERVICE CONNECTION AT EXISTING UTILITY. REFER TO THE BUILDING ELECTRICAL AND PLUMBING DRAWINGS FOR UTILITY SERVICE ENTRANCE LOCATIONS, SIZES AND CIRCUITING.
4. LOCATIONS OF PYLON / MONUMENT SIGNS AND ENTER / EXIT SIGNS ARE NOT EXACT. THE CONTRACTOR SHALL VERIFY EXACT LOCATIONS WITH OWNER / CONSTRUCTION MANAGER.
5. ALL LANDSCAPE AREAS SHALL BE ROUGH GRADED TO 6" BELOW TOP OF ALL WALKS AND CURBS. TOP SOIL TO BE ADDED TO THE LEVEL OF THE WALKS OR CURBS.
6. THE CONTRACTOR SHALL NOT DISTURB ANY ADJACENT PROPERTIES.

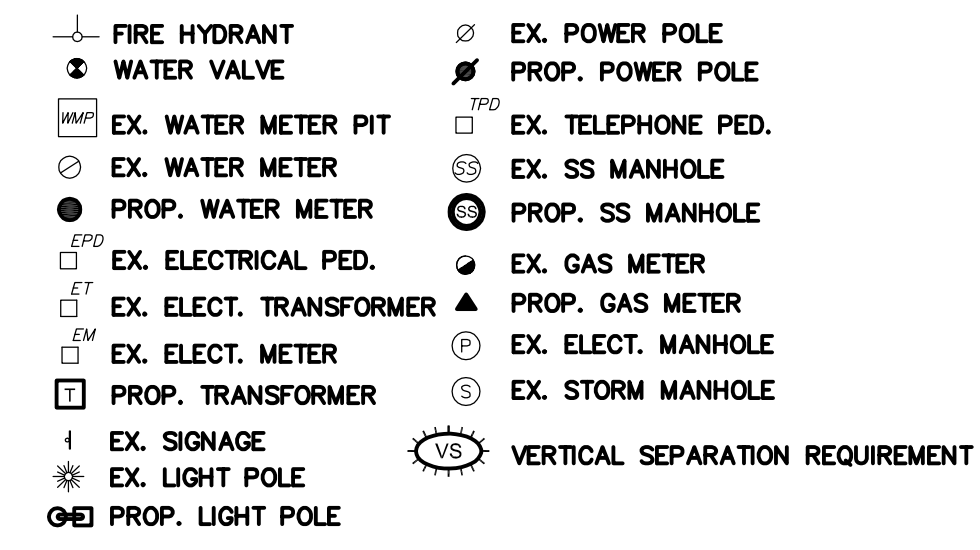
SITE PLAN KEYNOTES

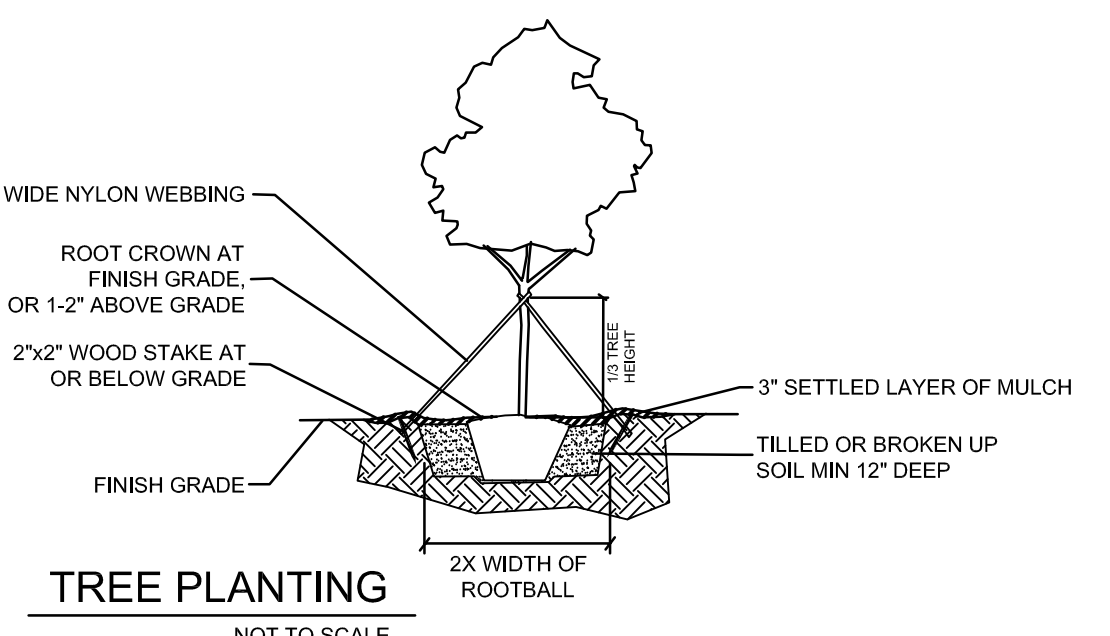
LEGAL DESCRIPTION

- A. NOTIFY LANDSCAPE ARCHITECT OR DESIGNATED REPRESENTATIVE OF ANY LAYOUT DISCREPANCIES PRIOR TO ANY PLANTING.
B. LOCATE ALL UTILITIES AND SITE LIGHTING CONDUITS BEFORE LANDSCAPE CONSTRUCTION BEGINS.
C. ALL SLOPES AND AREAS DISTURBED BY CONSTRUCTION, EXCEPT THOSE OCCUPIED BY BUILDINGS, STRUCTURES, OR PAVING SHALL BE GRADED SMOOTH AND FOUR INCHES (4") OF TOPSOIL APPLIED. IF ADEQUATE TOPSOIL IS NOT AVAILABLE ON SITE, THE CONTRACTOR SHALL PROVIDE TOPSOIL APPROVED BY OWNER, AS NEEDED.
D. TOPSOIL APPLICATION: PREPARE THE SUBGRADE BY DISK, HARROW, DRAG OR HAND RAKE TO A DEPTH OF 3" TO PROVIDE BOND FOR TOPSOIL. BEFORE PLACING TOPSOIL, RAKE SUBSOIL SURFACE CLEAR OF STONES LARGER THAN 1 1/2" DEBRIS AND ROOTS.
E. TOPSOIL SHALL POSSESS THE CHARACTERISTICS OF REPRESENTATIVE TOPSOILS IN THE VICINITY WHICH PRODUCES A HEAVY GROWTH; FREE OF SUBSOIL, OBJECTIONABLE WEEDS, LITTER, SODS, STIFF CLAY, STONES LARGER THAN 1" DIA, STUMPS, ROOTS, TRASH, TOXIC SUBSTANCES, OR ANY OTHER MATERIAL WHICH MAY BE HARMFUL TO PLANT GROWTH OR HINDER PLANTING OPERATIONS.
F. ALL TREES AND SHRUBS SHALL BE INSTALLED PER PLANTING DETAILS.
G. NO PLANT MATERIAL SHALL BE PLANTED IN FROZEN GROUND.
H. ALL PLANTING BEDS AS DESIGNATED SHALL BE BORDERED BY 4" INTERLOCKING ALUMINUM EDGING AND STAKED WITH METAL STAKES SUFFICIENTLY TO HOLD IN PLACE.
I. ALL PLANTED AREAS SHALL RECEIVE A LAYER OF SHREDDED PINE BARK MULCH OR SHREDDED HARDWOOD MULCH TO BE USED AS A THREE INCH (3") TOP DRESSING IN ALL PLANT BEDS AND AROUND ALL TREES OVER A 10 MIL "WEEDBLOCK" FABRIC.
J. FERTILIZE ALL PLANTS AT THE TIME OF PLANTING WITH 10-10-10 TIME RELEASE FERTILIZER.
K. SODDING SPECIFICATIONS: SODDED AREAS SHALL HAVE FERTILIZER APPLIED WITH A THOROUGH WATERING IMMEDIATELY FOLLOWING APPLICATION AT THE RATE OF 35 LBS. PER 1,000 SQ. FT. HARROWED INTO THE TOP 2".

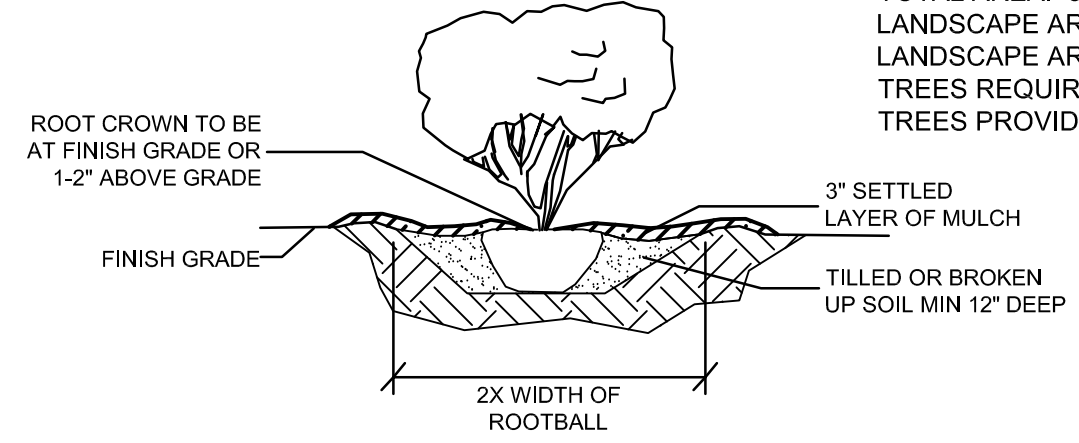

TREE PLANTING NOT TO SCALE



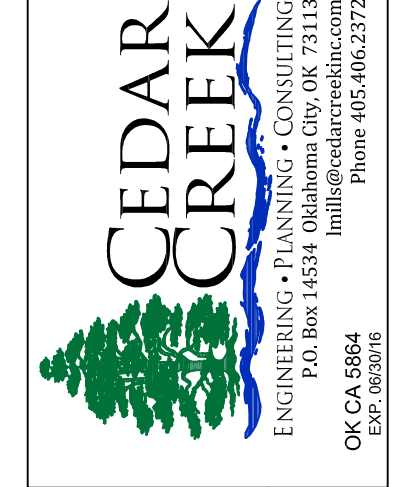
TYP. SHRUB PLANTING: NOT TO SCALE
