Shannon Marshall, Special Projects Division Manager, highlighted the item denoting that this would approve a contract for the funding of two special projects. The first would be a relief line to South Park South lift station and remove the lift station. This station, she explained, is just south of 121 Street, along where Elm Street is located. She then went on to explain the second project, which is to fund a trenchless installation of sanitary improvements at Houston Street. The cost for the two projects totals \$789,310.00. This bid comes to the council as the lowest responsible bid from a company called Cherokee Pride Construction, Inc.
