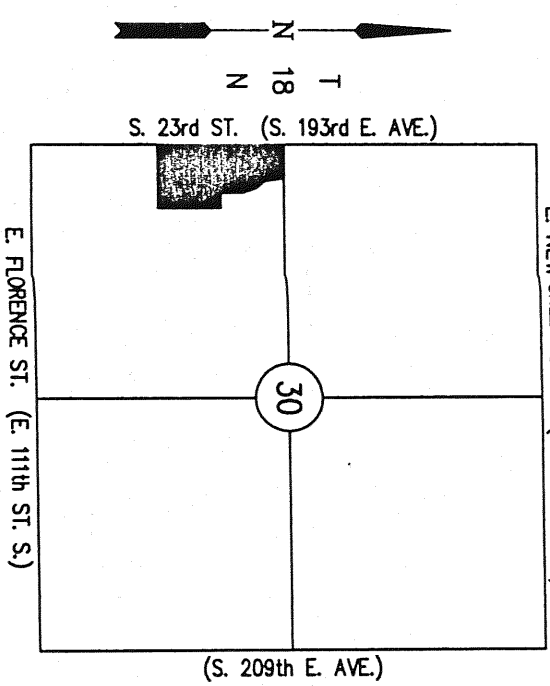

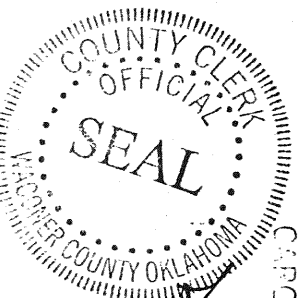
BACKFLOW PREVENTER VALVE TABLE
