## **RESOLUTION NO. 898**

A RESOLUTION FIXING THE AMOUNT OF SERIES 2016A BONDS TO MATURE EACH YEAR, FIXING THE TIME AND PLACE THE BONDS ARE TO BE SOLD AND AUTHORIZING THE CLERK TO GIVE NOTICE OF SAID SALE AS REQUIRED BY LAW; RATIFYING AND CONFIRMING A LEGAL SERVICES AGREEMENT AND A FINANCIAL ADVISOR SERVICES AGREEMENT WITH RESPECT TO THE ISSUANCE OF SUCH BONDS AND APPROVING THE PRELIMINARY OFFICIAL STATEMENT PERTAINING THERETO.

WHEREAS, on the 5th day of April 2011, pursuant to notice duly given, an election was held within the City of Broken Arrow, Oklahoma (the "City"), for the purposes of submitting to the qualified voters the question of the issuance of general obligation bonds of said City for specified purposes; and

WHEREAS, the issuance of bonds in and for the following principal amounts and respective purposes were authorized at said election: (i) \$27,000,000 to provide funds for the purpose of constructing and repairing streets within the City; (ii) \$10,000,000 to provide funds for the purpose of purchasing, constructing and repairing public safety utilities within the City; (iii) \$5,100,000 to provide funds for the purpose of purchasing, constructing, and repairing parks and recreation utilities of the City; and (iv) \$2,300,000 to provide funds for the purpose of constructing, reconstructing, improving and repairing the City's stormwater system; and

WHEREAS, the City previously issued \$11,450,000 principal amount of the above recited authorized bonds with the issuance of its General Obligation Bonds, Series 2011B dated August 1, 2011; and

WHEREAS, the City previously issued \$12,000,000 principal amount of the above recited authorized bonds with the issuance of its General Obligation Bonds, Series 2012 dated November 1, 2012; and

WHEREAS, the City previously issued \$6,200,000 principal amount of the above recited authorized bonds with the issuance of its General Obligation Bonds, Series 2013B dated December 1, 2013; and

WHEREAS, the City previously issued \$3,175,000 principal amount of the above recited authorized bonds with the issuance of its General Obligation Bonds, Series 2014B dated December 1, 2014; and

WHEREAS, staff has recommended and the governing body of the City has determined that the following bonds, which, when aggregated with the above referenced bonds, will constitute the total amount of bonds authorized at the election held on April 5, 2011, should be issued at this time for the respective purposes for which the same were authorized, to wit:

\$5,900,000 for constructing and repairing streets; \$3,000,000 for public safety utilities; \$1,625,000 for purchasing, constructing, and repairing parks and recreation utilities; and \$1,050,000 for constructing, reconstructing, improving and repairing the City's stormwater system,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BROKEN ARROW, OKLAHOMA:

<u>SECTION 1.</u> That \$11,575,000 principal amount of General Obligation Bonds, Series 2016A of the City of Broken Arrow, Oklahoma voted on the 5<sup>th</sup> day of April, 2011, shall be offered for sale at City Hall in said City on the 1st day of December, 2015, at 1:00 p.m., C.D.S.T., and that said Bonds shall become due \$605,000 in two years from their date and \$605,000 annually each year thereafter until paid, except that the last installment shall be for \$685,000.

SECTION 2. Municipal Finance Services, Inc., is hereby confirmed as Financial Advisor and Kiser Law Firm, PLLC as Bond Counsel to assist in the proceedings pertaining to the issuance of the Bonds. The Financial Advisor Services Agreement and Legal Services Agreement previously entered into by the City with such firms, respectively, each dated the 9<sup>th</sup> day of June, 2014, pertaining to the issuance of general obligation bonds by the City in one or more series are hereby ratified and confirmed.

SECTION 3. The Preliminary Official Statement dated of even date hereof, pertaining to the Bonds is deemed "near final" in accordance with the requirements of Rule 15c2-12 of the Securities and Exchange Commission promulgated pursuant to the Securities Exchange Act of 1934. The distribution of such Preliminary Official Statement by the Financial Advisor in connection with the public offering of the Bonds for sale is hereby authorized.

<u>SECTION 4.</u> The City Clerk is hereby directed to cause Notice of Sale of said bonds to be given as required by law.
