A. Public hearing, consideration, and possible action regarding PUD 94U and BAZ 1954, Battle Creek Patio Homes, 20.47 acres, PUD 94/CG to PUD 94U/RS-3, north of Albany Street, one-half mile east of Aspen Avenue

Brent Murphy presented the case noting the property location and indicated the applicant wished to construct a one-story patio home subdivision.

He said City Council, at their meeting of January 19, 2016, approved BACP-149 changing the Comprehensive Plan designation from Level 6 to Level 2, with the condition the property be platted and a Planned Unit Development (PUD) be submitted and approved.

Staff was recommending PUD 94U and BAZ 1954 be approved.

The applicant, J. Pat Murphy, Tulsa Engineering, 9820 E 41st Street, Tulsa, OK, was present and in agreement with staff recommendations.

The Public Hearing was opened. No one requested to speak. The Public Hearing was closed.

8. General Commission Business

A. Discussion regarding modifications to Section 3.1 (Table 3.1-1), Section 3.2.C, Section 10.3.D.4 of the City of Broken Arrow Zoning Ordinance

regarding Micro Food and Beverage Production

Farhad Daroga said the City has received several inquiries about micro-breweries for areas like the downtown district. He said the Zoning Ordinance does not address this type of operation and is geared more to larger operations and they are currently only allowed in Industrial Light and Industrial Heavy zoned areas. Staff is recommending the zoning ordinance be allow micro-breweries micro-food modified to and operations commercially zoned areas with a specific use permit.

The definition of a micro-brewery is set by the State. The Food & Drug Administration says the number of barrels that can be produced is controlled by state legislation. The Specific Use process would allow the city to scrutinize and evaluate the operation. If the State laws change, our laws would also change.

This item is for discussion only. No vote was taken.

B. Discussion regarding modifications to Section 5.7.C.3 of the City of Broken Arrow Zoning Ordinance regarding Separation of Signs
