



DESCRIPTION

A TRACT OF LAND SITUATE WITHIN A PORTION OF THE NORTH HALF (N/2) OF THE SOUTHWEST QUARTER (SW/4) OF SECTION TWO (2), TOWNSHIP EIGHTEEN NORTH (T18N), RANGE FIFTEEN EAST (R15E) OF THE INDIAN MERIDIAN (I.M.) IN WAGONER COUNTY, OKLAHOMA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A FOUND BRASS CAP IN THE CENTER OF MIDWAY ROAD RIGHT-OF-WAY FOR THE NORTHWEST CORNER OF SAID N/2 SW/4; THENCE N88° 50' 58"E A DISTANCE OF 1961.22 FEET; THENCE S01° 09' 02"E A DISTANCE OF 430.35 FEET TO THE POINT OF BEGINNING; THENCE N88° 50' 59"E A DISTANCE OF 107 FEET TO A POINT ON CURVE TO THE RIGHT; THENCE 20.42 FEET ALONG THE ARC OF SAID CURVE HAVING A RADIUS OF 13 FEET, SUBTENDED BY A CHORD OF 18.38 FEET WHICH BEARS S46° 09' 01"E; THENCE N88° 50' 59"E A DISTANCE OF 50.00 FEET TO A POINT ON CURVE TO THE RIGHT; THENCE 20.42 FEET ALONG THE ARC OF SAID CURVE HAVING A RADIUS OF 13 FEET, SUBTENDED BY A CHORD OF 18.38 FEET WHICH BEARS N43° 50' 59"E; THENCE N88° 50' 59"E A DISTANCE OF 149.39 FEET; THENCE S01° 09' 01"E A DISTANCE OF 15.00 FEET; THENCE S88° 50' 59"W A DISTANCE OF 31.39 FEET; THENCE S01° 09' 01"E A DISTANCE OF 14.00 FEET; THENCE S88° 50' 59"W A DISTANCE OF 22.00 FEET; THENCE N01° 09' 01"W A DISTANCE OF 14.00 FEET; THENCE S88° 50' 59"W A DISTANCE OF 268.00 FEET; THENCE S01° 09' 01"E A DISTANCE OF 305.00 FEET; THENCE S88° 50' 59"W A DISTANCE OF 22.00 FEET; THENCE N01° 09' 01"W A DISTANCE OF 60.00 FEET; THENCE N88° 50' 59"E A DISTANCE OF 11.00 FEET; THENCE N01° 09' 01"W A DISTANCE OF 260.00 FEET TO THE POINT OF BEGINNING.

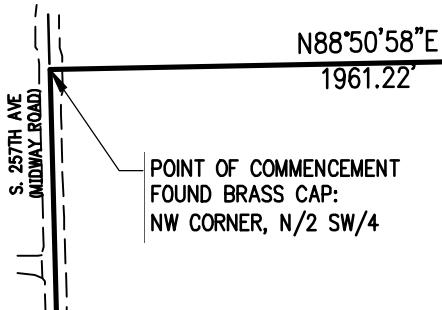

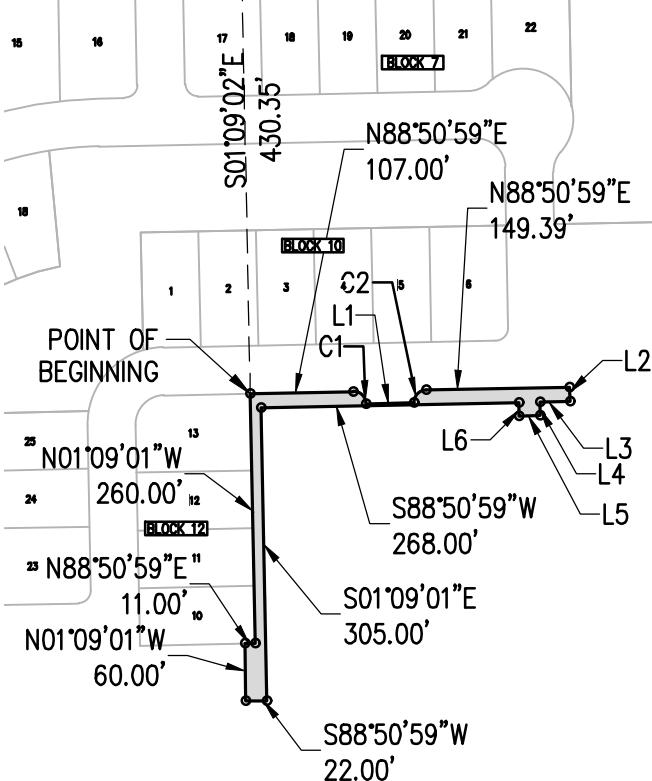

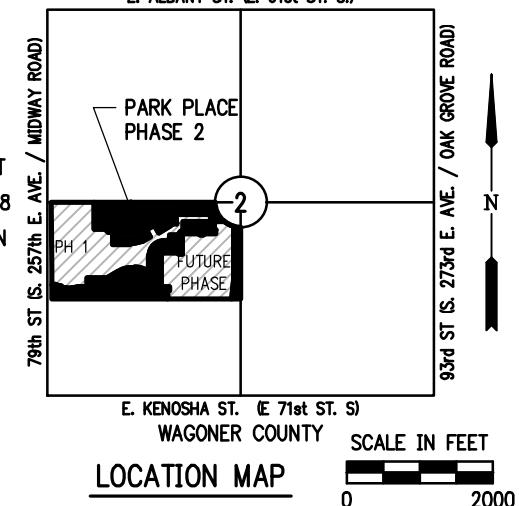
