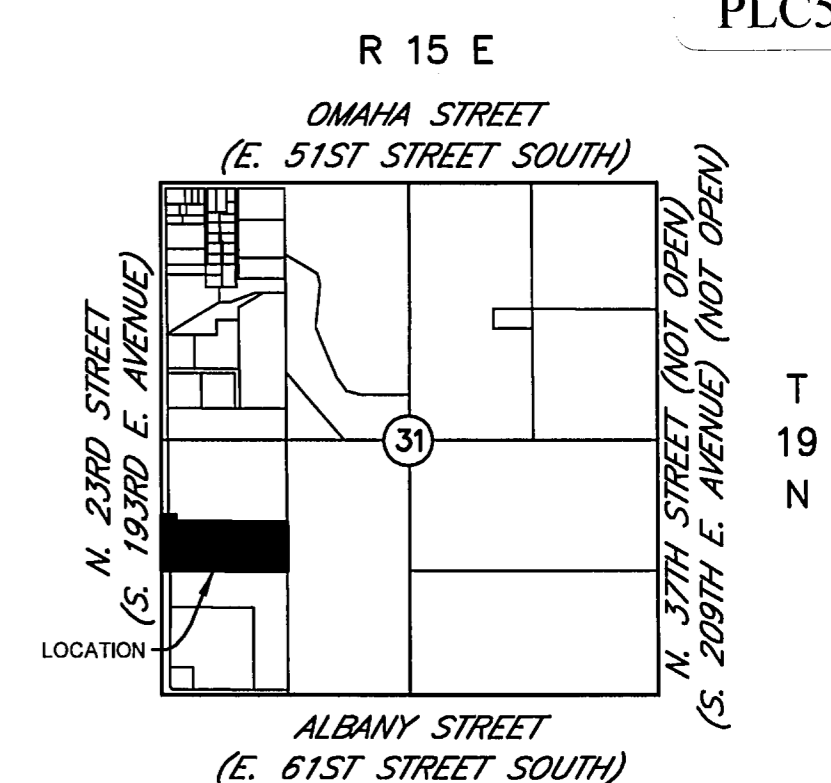


FINAL PLAT OF THE PARK AT ALBANY PUD 217

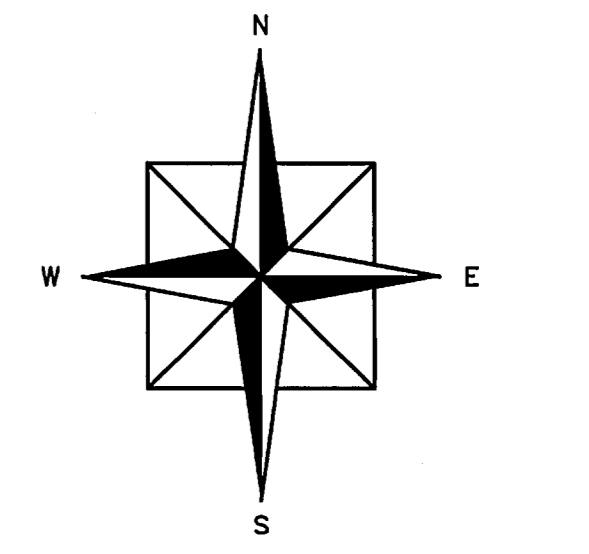

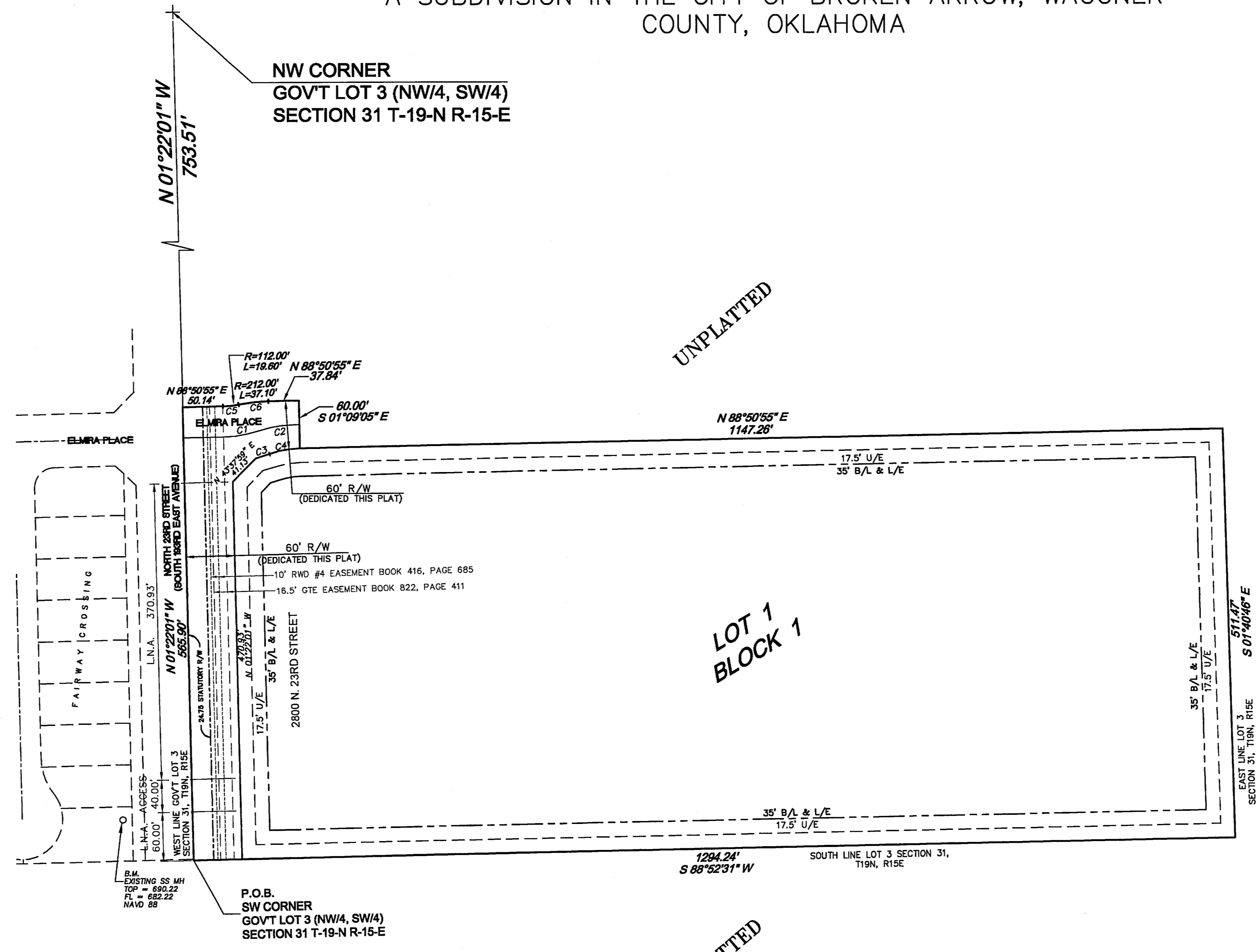
LOCATION MAP

LEGAL DESCRIPTION

A TRACT OF LAND BEING A PART OF GOVERNMENT LOT 3 OF SECTION 31, TOWNSHIP 19 NORTH, RANGE 15 EAST OF THE INDIAN BASE AND MERIDIAN, WAGONER COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE U.S. GOVERNMENT SURVEY THEREOF, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
 BEGINNING AT THE SW CORNER OF SAID GOVERNMENT LOT 3; THENCE N 01°22'01" W ALONG THE WEST LINE OF LOT 3, A DISTANCE OF 565.90 FEET;
 THENCE N 88°50'55" E, A DISTANCE OF 50.14 FEET;
 THENCE ON A CURVE TO THE LEFT, HAVING A CENTRAL ANGLE OF 10°01'38" AND A RADIUS OF 112.00 FEET A DISTANCE OF 19.60 FEET WITH A CHORD BEARING OF N 83°50'06" E A CHORD LENGTH OF 19.58 FEET;
 THENCE ON A CURVE TO THE RIGHT, HAVING A CENTRAL ANGLE OF 10°01'38" AND A RADIUS OF 212.00 FEET A DISTANCE OF 37.10 FEET WITH A CHORD BEARING OF N 83°50'06" E A CHORD LENGTH OF 37.05 FEET;
 THENCE N 88°50'55" E, A DISTANCE OF 37.84 FEET;
 THENCE S 01°09'05" E, A DISTANCE OF 60.00 FEET;
 THENCE N 88°50'55" E, A DISTANCE OF 1147.26 FEET TO A POINT ON THE EAST LINE OF LOT 3;
 THENCE S 01°40'46" E ALONG SAID EAST LINE, A DISTANCE OF 511.47 FEET TO A POINT ON THE SOUTH LINE OF LOT 3;
 THENCE S 88°52'31" W ALONG SAID SOUTH LINE, A DISTANCE OF 1294.24 FEET TO THE POINT OF BEGINNING, CONTAINING 669115.32 SF OR 15.36 ACRES.
