The City of Broken Arrow will hold a virtual public hearing on February 15, 2024 at 2:00 PM, a link to the hearing can be found at <https://www.brokenarrowok.gov/Home/Components/RFP/RFP/557/1066>. The hearing is to discuss the proposed Wagoner County Trunk Sewer Improvements, alternatives to the proposed improvements and their associated costs. One purpose of the hearing is to discuss the potential environmental impacts of the project and the alternatives to it.

The proposed project is identified in the Planning and Environmental Information Document and consists of the following major elements:

- Construct a sanitary sewer to rehabilitate and/or replace the existing Wagoner County Trunk Sewer Line to improve flow and help facilitate capacities of new developments in the area.
