Background

Lessor and Southwestern Bell Mobile Systems, Inc. (the "Original Lessee") entered into a certain Lease Agreement dated October 21, 1996 concerning the leasing of a portion of the Property, including a portion of Lessor's communications tower (the "Tower") located on the Property, as amended and restated by that certain Amended and Restated Site Use/Lease Agreement dated July 19, 2016 ("Existing Lease") and amended June 30, 2017 ("First Amendment") between Lessor and Lessee. Lessee is the successor in interest to the Original Lessee and has been operating at the Property pursuant to the terms of the Existing Lease. The parties hereto desire to amend the Existing Lease as set forth herein.

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lessor and Lessee agree as follows:

1. Equipment and Use.

Lessor consents to the installation, modifications and operation of antennas, associated cables and equipment on the Tower and the Premises as more completely described on attached $\underline{\text{Exhibit A}}$ attached hereto. Lessor's execution of this Amendment will signify Lessor's approval of $\underline{\text{Exhibit A}}$.

2. Rent.

Commencing on December 1, 2017, Section 4 of the Existing Lease is modified to increase the monthly Rent by One Hundred Fifty and No/100 Dollars (\$150.00).

- 3. Other Terms and Conditions Remain. In the event of any inconsistencies between the Existing Lease and this Second Amendment, the terms of this Second Amendment shall control. Except as expressly set forth in this Second Amendment, the Existing Lease otherwise is unmodified and remains in full force and effect. Each reference in the Existing Lease to itself shall be deemed also to refer to this Second Amendment.
- 4. Capitalized Terms. All capitalized terms used but not defined herein shall have the same meanings as defined in the Existing Lease.
