

**AMENDMENT TO WINDSTREAM AGREEMENT**

This AMENDMENT ("Amendment") effective as of the latter of the signature dates below, amends the Agreement with an Effective Date of February 20, 2025 (Quote # 2872869), in addition to any and all related addenda or amendments (collectively, the "Agreement"), by and between **City of Broken Arrow** ("Customer") and the Windstream legal entity(ies) providing the Service to Customer, as identified on Customer's bill ("Windstream").

**TERMS OF AMENDMENT**

1. Windstream and Customer hereby agree to amend the Agreement by adding the new Service locations, as identified in Attachment A, attached hereto and hereby incorporated into the Agreement. The Services to be provided at such Service locations and rates for the same are also set forth in Attachment A.
2. **Monthly Recurring Charge.** The Monthly Recurring Charge ("MRC") for the Services being ordered shall be \$5,970.00 exclusive of all taxes, surcharges and other fees which may be applicable to Services ordered hereunder.
3. **Non-Recurring Charge.** The Non-Recurring Charge ("NRC") for Services ordered hereunder shall be \$8,970.00 exclusive of all taxes, surcharges and other fees which may be applicable
4. Except as modified by this Amendment, the terms and conditions set forth in the Agreement remain unchanged. All amended Services are subject to the Term stated on the Quote.
