KNOW ALL MEN BY THESE PRESENTS:

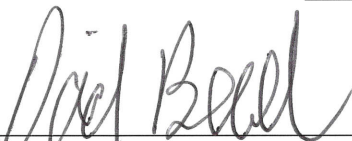

This grant of temporary right to use and occupy is given for the purpose of permitting the City of Broken Arrow, its employees, representatives, agents, and/or persons under contract with it, to use said described property for construction of street improvements for the Florence Street Improvements, Olive to Aspen, project # ST1410.

That the Owner(s) agree that this temporary construction easement shall be binding upon their heirs, executors, administrators and personal representatives during the term hereof and further agree that in the event the premises covered by this temporary construction easement are sold, assigned or conveyed, that the purchaser or grantee thereof will be advised of the existence of this temporary grant and that said sale during said term shall be made subject to the rights herein given.

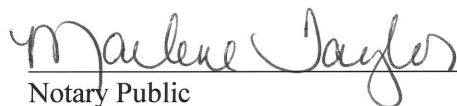

LEGAL DESCRIPTION:

A strip, piece or parcel of land lying in part of the SW¼ SE¼ SW¼ of Section 28, Township 18 North, Range 14 East, IM, Tulsa County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the Southwest corner of said SW¼ SE¼ SW¼, thence N 01°25'18" W along the West line of said SW¼ SE¼ SW¼ a distance of 90.00 feet to the point of beginning, thence continuing N 01°25'18" W along said west line a distance of 20.00 feet, thence N 88°34'42" E along a line parallel to and 110.00 feet North of said South line a distance of 151.28 feet, thence S 46°25'18" E a distance of 98.99 feet to a point on the North permanent right of way line of Florence Street, thence S 88°34'42" W along said North permanent right of way line a distance of 28.28 feet, thence N 46°25'18" W along said North permanent right of way line a distance of 70.71 feet, thence S 88°34'42" W along said North permanent right of way line a distance of 143.00 feet to said point of beginning.

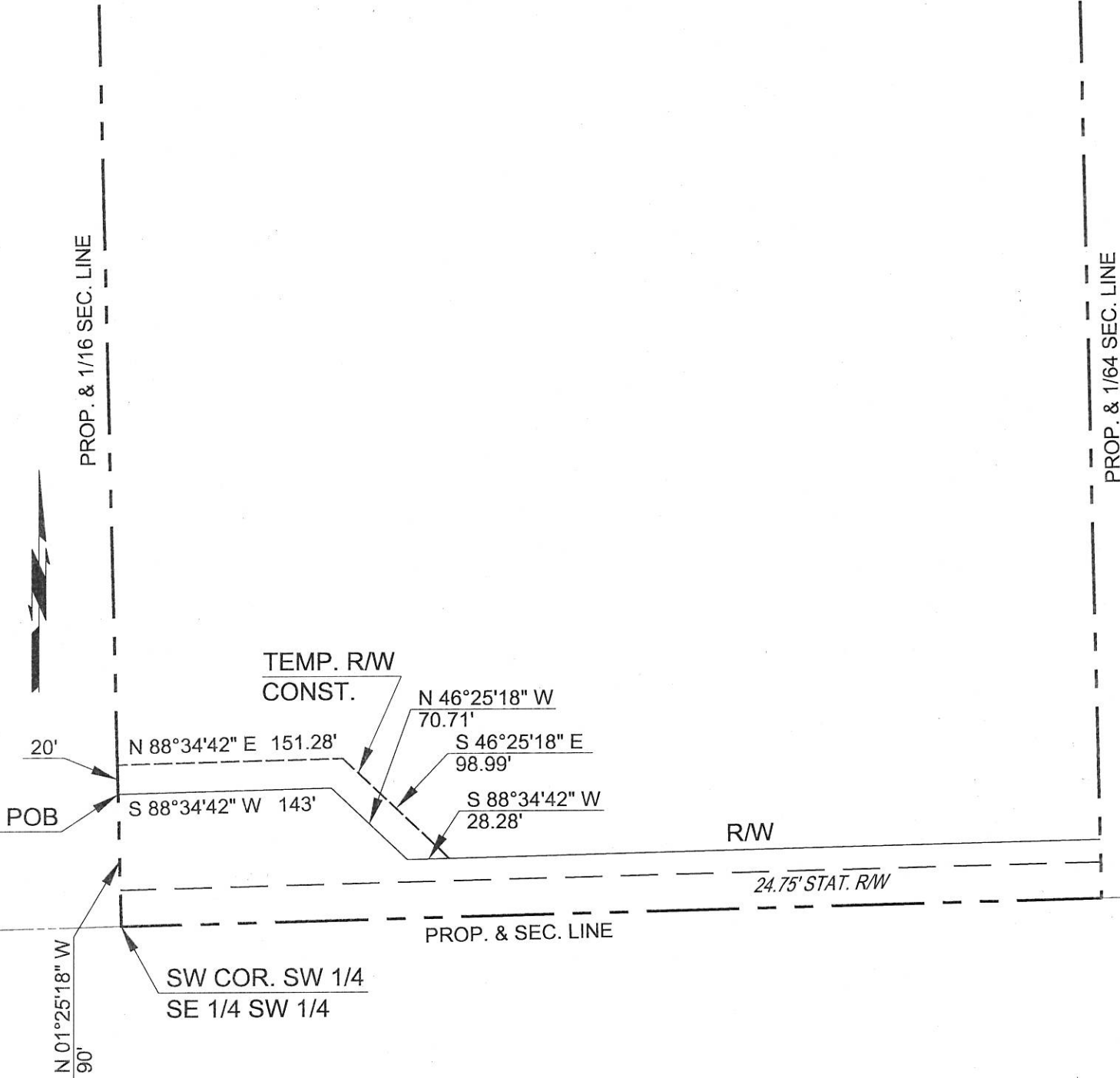
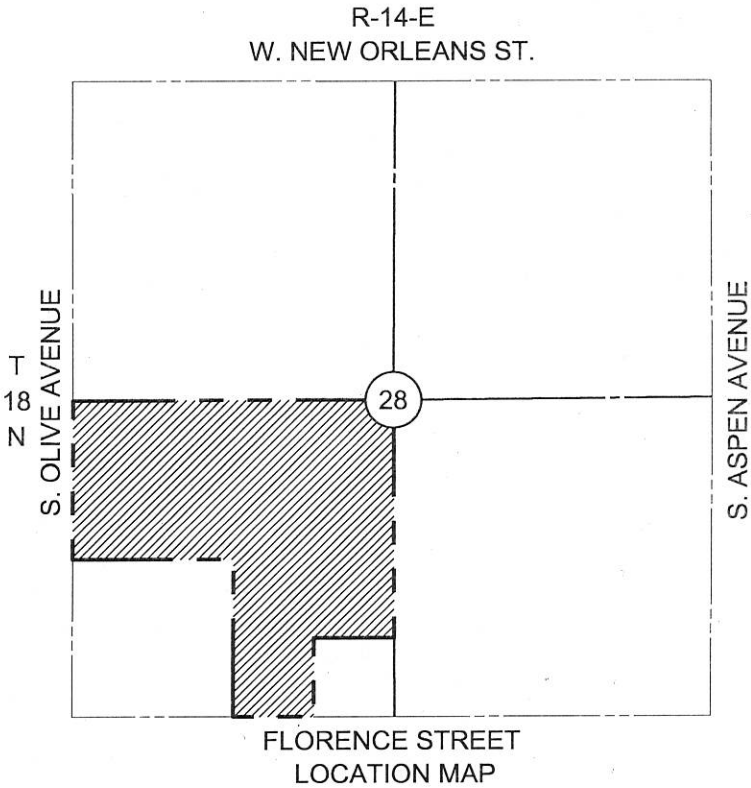
