

AN ORDINANCE AMENDING ORDINANCE NO. 302, APPROVING B.A.Z NOS. 306, 307, 308, 309, 310, 311, 312, and 313, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BROKEN ARROW, OKLAHOMA:

SECTION 1. That the zoning classification of the following described real estate, situated in Tulsa County, State of Oklahoma, to wit:

conflict herewith be and the same are hereby repealed.

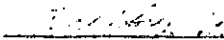
SECTION 22. That an emergency exists for the preservation of
