Thence N 01°36'51" W on the East line of said Southeast Quarter (SE/4) a distance of 1,654.73 feet;

Thence S 88°23'09" W a distance of 24.75 feet to a point on the West Statutory Right of Way line of South Aspen Avenue, said point also being on the South line of a property described in Document #2012080835 filed for record at the Tulsa County Clerk's office, said point being the Point of Beginning;

Thence S 88°42'39" W on the South line of said property a distance of 25.25 feet;



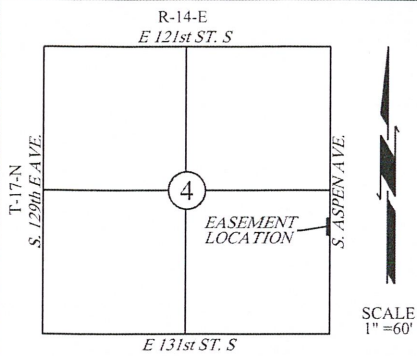
