DESCRIPTION

The applicant lives on an unplatted property located along Broken Arrow Creek, south of E. Washington St. and west of Lynn Lane Rd. The only access to the property is across Broken Arrow Creek. The driveway is considered a low water crossing and is comprised of three 30-inch culverts. The driveway and bridge are washing out and the property's yards upstream become lakes with each substantial rain event. This area is located in a floodplain and floodway. The applicant is asking for the city's help for a more sustainable fix and to help alleviate flooding upstream contingent upon the city obtaining ownership of a shared private driveway. This private road is the only road to access the property.

Staff is requesting \$125,000.00 for design funds.

Location of Drainage Issue on Property

Culvert bridge over dry creek that is only in and out of property.

Description of Problem

Culvert bridge with 3 30" pipes cannot handle big rains and drainage from the north (softball fields and branch creek). Our roadway and bridge continually washes out and upstream homes are in danger of continual flooding. Their yards become lakes with each substantial rain. We have to spend thousands to repair and reconstruct the culvert bridge with each flood. We need help with a more sustainable fix.

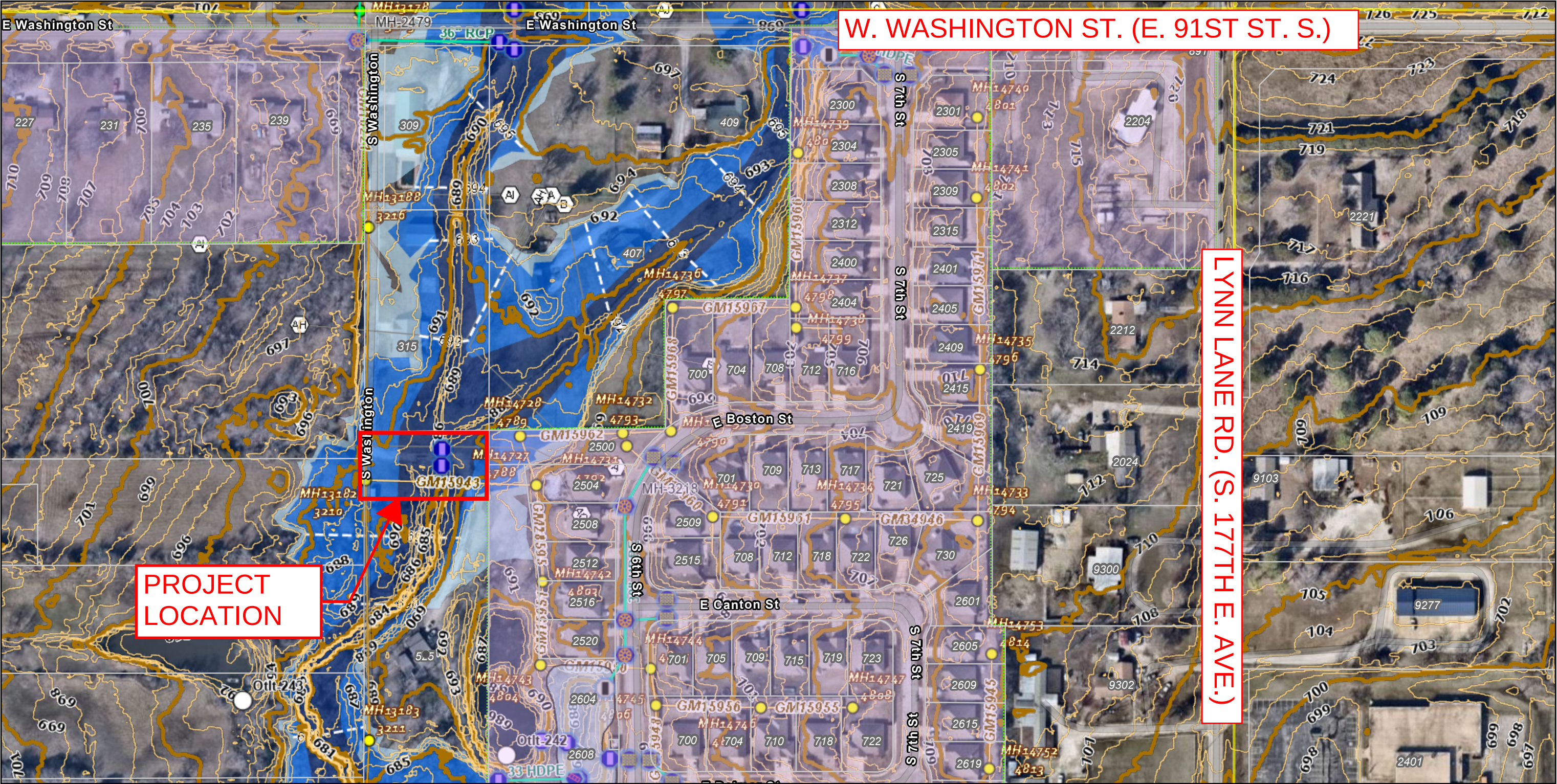

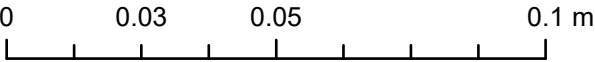
