

**AMENDMENT NO. 1
TO THE PROFESSIONAL CONSULTING SERVICES AGREEMENT BETWEEN THE
CITY OF BROKEN ARROW AND DESTINATION SERVICES, LLC.**

THIS **AMENDMENT NO. 1**, made and entered into this ___ day of January 2017, by and between the CITY OF BROKEN ARROW, OKLAHOMA, a municipal corporation of the State of Oklahoma, hereinafter referred to as “CITY”, and DESTINATION SERVICES, LLC, hereinafter referred to as “Destination Services”.

WITNESSETH:

WHEREAS, CITY and Destination Services entered into an Agreement dated June 20, 2017, for services as set forth in said Agreement; and

WHEREAS, said Agreement requires Destination Services to provide a Strategic Planning and Study Deliverables; and

WHEREAS, CITY and Destination Services propose to amend said Agreement to clarify compensation; and

WHEREAS, the Original Agreement and First Amendment shall hereinafter collectively be referred to as the “Agreement”; and

WHEREAS, funding is now available for said additional services.

NOW THEREFORE, in consideration of the promises contained herein, the parties hereto agree to amend the Agreement as follows:

1. **CHANGE IN CONTRACT AMOUNT.**

The City shall pay Destination Services incurred traveling expenses for consultant to travel to the City of Broken Arrow in the amount of \$1,840.17.

2. **EFFECTIVE DATE AND AUTHORIZATION TO PROCEED.**

This Amendment No. 1 is effective upon signature by both parties.

Except as amended hereby, all terms of the Original Agreement shall remain in full force and effect without modification or change.
