13. Remarks by City Manager

City Manager, Mr. Michael Spurgeon, said he would be meeting with the Construction and Engineering Department to discuss the needed professional services for the projects that would be funded by the General Obligation Bonds approved earlier during the Council meeting.

Mr. Spurgeon said with regard to the remaining 2014 projects, the goal was to complete those projects over the next three years. He said the Department Directors would be meeting on the week of January 11, 2016 to determine priorities for the 2014 projects. Mr. Spurgeon mapped a process of presenting the collective recommendations to Council for approval and then a plan to revisit the recommendations during the budget session to determine if there are any changes. He said at that time Staff would look to Council to issue approvals so that they could move forward. Mr. Spurgeon said this process would be repeated for the following two years.

Mr. Spurgeon said that in the fall of 2016 an eighteen month process would be launched to consider all emerging projects to be considered for the next round of Bond Obligations slated for 2018.

Mr. Spurgeon referred to the Vison 2025 renewal saying that during the first week of January 2016 operational meetings would be held with the City Attorney, the Finance Director, and applicable Department Directors to begin the process of implementing the projects approved by voters. He said implementation would begin in January of 2017 after all preparations and personnel are in place. He said announcements would be made to the Council and the public throughout the process.

Mr. Spurgeon thanked the Broken Arrow Chamber Of Commerce for sponsoring the Tree Lighting Ceremony in the Rose District Pavilion. He thanked the Students of the Broken Arrow Dance Program for their interpretive dance performance at the Ceremony.

Mr. Spurgeon announced the Ruts 'n Guts Cycling Event held at the Chisholm Trail

Events Park. He gave his thanks to the Parks Department and noted that this event was fast becoming a signature event here in Broken Arrow.

Councilor Mike Lester reminded all of the Christmas Parade planned for 10:00 a.m. in the Downtown Rose District on Saturday, December 5, 2015.
