







LOCATION MAP SCALE: 1"=4000"

## **LEGAL DESCRIPTION**

A STRIP OF LAND SITUATED IN PART OF RESERVE AT THE PINES III, A SUBDIVISION IN WAGONER COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT THEREOF, SAID STRIP OF LAND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
