- A. 25-1047 Consideration, discussion, and possible approval of October Best Practices Trip**

James Bell presented Item 25-1047, details on the upcoming Chamber Best Practices trip to Franklin and Murfreesboro, Tennessee, explaining that the purpose of such visits is to learn from aspirational communities, avoid costly mistakes, and gather ideas that can support Broken Arrow's intentional and sustainable growth. Past trips have yielded inspiration, such as Carmel, Indiana's influence on the Rose District.

Franklin offers lessons in downtown redevelopment, retail attraction beyond big-box stores, and adaptive reuse projects like the Factory at Franklin, which has become a vibrant hub. The trip will also include a visit to Williamson County Schools' Entrepreneurship and

Innovation Center, where students gain hands-on experience in entrepreneurship, cybersecurity, robotics, and e-sports.

Murfreesboro will showcase how relocating city hall spurred downtown revitalization beyond the central square, offering a glimpse into Broken Arrow's near-term future, while Franklin represents a longer-term vision. The visit will also highlight Middle Tennessee State University's role in the city's growth. Mr. Bell emphasized the trip's value in exploring how suburban cities can balance growth, retain family-oriented values, and support entrepreneurs within larger regional ecosystems, inviting feedback on what participants want to learn.

City Manager Michael Spurgeon, praised the upcoming best practices trip, noting past visits consistently reinforce pride in Broken Arrow while still providing valuable ideas. He commended James Bell and his team for selecting Franklin and Murfreesboro as aspirational cities that closely align with Broken Arrow's goals, predicting it could be the most impactful trip since the Overland Park visit that inspired the city's conference center and hotel discussions.

Mr. Bell confirmed the trip dates as October 27–29. He explained the goal is to engage directly with city officials and organizations that are slightly ahead of Broken Arrow in areas like downtown development and city hall planning. Trustees emphasized the importance of gathering ideas, likening it to educators borrowing best practices from multiple sources. Mr. Bell asked attendees to prepare questions in advance so their hosts in Franklin and Murfreesboro can tailor responses, noting his team is coordinating closely with local chambers of commerce and economic development groups.
