Subject: Trafic Calming Program

Dear Mr. Harrison;

On June 2, 1997, the Broken Arrow City Council adopted a Traffic Calming Policy. This policy was established to reduce speeding in subdivisions. The Policy was effective as of July 1, 1997, and the Traffic Division of the Streets and Stormwater Department is responsible for impleinting this policy. The last revision of this policy was September 29, 2015.

You have requested that West Boston Street be added to the list of the streets being considered for traffic calming measures. You have agreed to serve as the sponsor. At this point the Traffic Division will conduct a traffic count and 24 hour speed survey on this street. If the surveys indicate a need for further action, we will then advise you of the next step to be taken and provide the necessary forms. It would be at this point, providing the count and speed survey meet criteria, that the petition would be circulated. If the traffic count or speed survey does not show a need for further action, you will receive a letter informing you of the results.

Attached is a pamplet describing the traffic calming program and the steps needed to get the program started. If you have any questions concerning the program please call the Street and Stormwater Department at (918) 259-7000, extension 7380.

Thank you for your interest in our City. The paticipation of you and your neighbors help make the City streets a safer place for all the citizens of the City.
