Venu, formerly known as Notes Live, recently received investment interest and has made design adjustments, such as relocating owner suites. The venue is still on track, with the first concert anticipated soon, and an operational meeting is planned for next season. They hope to extend the concert season into November due to favorable weather in Oklahoma. The official groundbreaking for the venue is set for October 11th.

For the Arrow Forge Innovation District, a groundbreaking ceremony is scheduled for this

Friday at 10:00 a.m. Two infrastructure contracts have been awarded, and the Economic Development Council (EDC) is working on strategies to attract businesses. The EDC plans to meet with site selectors soon, aiming to make significant announcements by 2025, and they already have an agreement with their first business.

Mr. Spurgeon expressed excitement about the progress and emphasizes ongoing efforts to keep these projects moving forward.
