6. Consideration of Items Removed from Consent Agenda

There were no items removed from the Consent Agenda. No action was required or taken.

7. Public Hearings, Appeals, Presentations, Recognitions, Awards

There were no public hearings, appeals, presentations, recognitions, awards or oaths. No action was required or taken.

8. Citizens' Opportunity to Address the Council on General Topics

Mr. Richard Pisaturo, Broken Arrow Citizen, gave the Council an update on code enforcement for the parking of illegal commercial vehicles parking on residential streets. He said that his neighborhood would be receiving news letters to help educate the residents on the new regulations as ignorance of the codes appeared to be one of the main reasons for continuing issues. He told the Council that he was thankful and impressed with the support he had received from the City's staff. Mr. Pisaturo asked if it would be possible for the City to sponsor a class for leaders of the City's Home Owners Associations. Councilor Richard Carter thanked Mr. Pisaturo for his support. No Action was required or taken.

9. General Council Business

A. 15-244 Consideration, discussion, possible approval of and authorization to execute an Employment Agreement between the City of Broken Arrow, Oklahoma and Michael L. Spurgeon

City Attorney, Ms. Beth Anne Wilkening, told the Council she has had a number of conversations with the new City Manager, Mr. Michael L. Spurgeon, and he is very excited about assuming his position. She said he currently serves as Director of Administration for the City of St. Charles, Missouri. She said he had spent a considerable amount of time as City Administrator/Manager for Miami, Oklahoma. Ms. Wilkening said that the attached employment agreement was consistent with those

utilized by other municipalities. She said it provides for his appointment as City Manager for a period of three years at an annual salary of \$166,000.00. The Agreement provides for transportation and technology allowances, a bank of two weeks sick and vacation leave, payment of relocation expenses, a relocation preparation trip, a transitional living allowance, and retirement contributions of 12%. It also contains a nine (9) month severance package for two years. The severance package is reduced to seven (7) months in the third year. The Agreement provides for a start date of September 21, 2015, a preliminary review after six (6) months and annual reviews thereafter. Ms. Wilkening gave further details related to the employment contract with Mr. Spurgeon. She said that it was staff's recommendation that Council approve the Employment Agreement and authorize its execution.

B. 15-273 Consideration, discussion, possible approval of and authorization to execute the Fiscal Year 2015-16 Labor Agreement with the International Association of Firefighters Local No. 2551

Acting Director of Human Resources, Ms. Jannette McCormick, told the Council that the City's negotiation team and the International Association of Fire Fighters Local No 2551 began negotiations in March of 2015 for the Fiscal Year 2015-16 Labor Agreement. She said that an agreement was reached on July 16, 2015 and ratified by the local membership. Ms. McCormick said that there were several administrative changes and she presented the following items with economic impact:

- 1. A 3% base wage increase for all bargaining unit members
- 2. A 15% increase in the health insurance contribution for bargaining unit members

She said that staff recommended approval of the agreement and authorization of its execution.

C. 15-276 Consideration, discussion, possible approval of and direction to publish an Amended Legal Notice of Annexation for the voluntary annexation of approximately 14 acres of land located in the West Half of the Northwest Quarter of the Northwest Quarter (W/2 NW/4 NW/4) of Section Nine (9), Township Seventeen (17) North, Range Fourteen (14) East of the Indian Base and Meridian, Tulsa County, State of Oklahoma, and generally located on the Southeast corner of 131st Street and 129th East Avenue (Olive) and being adjacent to and abutting 131st Street and 129th Street East Avenue (Olive)

Ms. Wilkening told the Council that this item was considered at the last meeting and due to some difficulty with the legally required publication date the staff recommended a direction from Council to publish the Amended Notice.

D. 15-263 Consideration, discussion, possible approval of and authorization to execute Resolution No. 887, a Resolution authorizing the City Attorney to agree to Entry of Judgment without admitting liability in the matter of First Pryority Bank v. City of Broken Arrow, Wagoner County District Court, Case No. CJ-2015-0180; and directing the City Attorney to prepare and file the necessary documents to effectuate settlement, including a Journal Entry incorporating the Resolution of the Court's approval, pursuant to 51 O.S. § 158

Ms. Wilkening explained that this item had initially been a tort claim that was denied by

the Tort Claim Committee. She explained the peculiarities of the case that related to the demolition of an abandoned house located at 2400 East 71st Street South, Broken Arrow, Oklahoma. She said that a reasonable compromise determined a value of settlement in the amount of \$30,000.00, plus the release of the Notice of Dilapidation and Lien. Ms. Wilkening told the Council that staff had been engaged in the issues related to the case and efforts were underway with Wagoner County to address the circumstances that lead to the case. She added that safeguards that had been implemented would hopefully eliminate future complications.

Ms. Wilkening said that Section 24-704 had been inadvertently omitted from the process to remove fees found within Ordinances and the establishment of those fees within the Manual of Fees. The fees referenced within the Amendment relate to rates for sanitary sewer service.

She said Ordinance 3356 pertains to the Defined Contribution Plan established for the position of City Manager. She said that this is new because prior City Managers had to avail themselves of the retirement plan through International City/County Management Association. Ms. Wilkening said the change responded to requirement from the Internal Revenue Service. She gave details of the new requirements. Ms. Wilkening said Ordinance 3357 pertains to the Employee Retirement System. She said that it was recommended by staff that Council adopt both Ordinances.
