ARTICLE VIII  
FINAL PROVISIONS

Section 8.01. TERM OF CONTRACT: Change the term of contract from "forty-two (42) years" to "forty-three (43) years". The purpose of this extension is to allow time for the RMUA to update provisions of this contract, especially any content that would be applicable to new participating members desiring to contribute wastewater flow to the Hailey Creek Treatment Plant.
