The techs worked long hours in order to meet the customer needs. The motors were found to need new bearings, fan blades, washed and baked. The electrical readings are lower than desired but they can still run normally. The readings are lower due to the motors getting overheated at times. You can tell this by looking at the color of the windings in the stator. All motors had the same issues as listed above. Once the motors were installed the customer started having problems with mop heads clogging the pumps and having issues with the VFD system. Cogent techs went back to the site several times in order to get the customer up and running. Issues found during the return trips by Cogent techs were, clogged pumps, VFD system was not working, bad bearings in pumps (the customer fixed this issue), overload warnings.
