Mayor Thurmond introduced the new City Manager, Mr. Michael Spurgeon.

7. Public Hearings, Appeals, Presentations, Recognitions, Awards

There were no public hearings, appeals, presentations, recognitions, awards or oaths. No action was required or taken.

8. Citizens' Opportunity to Address the Council on General Topics Related to City Business or Services (No action may be taken on matters under this item)

No citizens signed up to speak.

9. General Council Business

- A. 15-470 Consideration and possible approval of PUD 240 and BAZ 1942, Villas at Bricktown, 11.58 acres, Rezoning R-1 to PUD (Planned Unit Development) 240/RS-3, and abrogation of BACP 87, north of the northeast corner of Kenosha Street and Olive Avenue

Mayor Thurmond turned the meeting over the Vice Mayor Richard Carter and recused himself. Mayor Thurmond left the room.

City Planner, Mr. Farhad Daroga told the Council that this application for BAZ 1942 had been submitted with a PUD 240 for an eleven and one half acre site located north of the northeast corner of Kenosha Street and Olive Avenue. He said that the Council had reviewed this application briefly at the last Council meeting for the development of a gated community with thirty six lots. Mr. Daroga said that the Planning Commission had recommended approval.

Vice Mayor Carter invited the applicant to speak.

Mr. Dan Tanner of Tanner Consulting told the Council the development was subject to onsite detention and the planned modification of the floodplain would require Federal Emergency Management Agency (FEMA) approval. He said that Tanner Consulting had met with City staff and recommendations had been incorporated into the plan.

Councilor Mike Lester said he understood that there could be no development in the floodplain area. He asked how the developer intended to insure that property owners, whose properties backup to the floodplain, do not build anything in the plain. Mr. Tanner clarified that there were regulations that allowed alterations to a floodplain and that the planned development in this case would modify the floodplain with minor shaping and grading. He continued by saying that a restrictive covenant would accompany the Plat that would be enforceable by the City.

Councilor Parks said that this area had flooding issues. He said much of the development in that area took place before it was annexed into the City. Councilor Parks asked how the plan would address the flooding concerns. Mr. Tanner said that modifications to the floodplain were planned to clean and simplify the area and then the detention pond would be located outside the floodplain area. Council Parks asked for specification that addressed size of lots and the external finish of the houses. Mr. Tanner said all of those elements were defined in the PUD.

Mr. Skates said this was a request to establish a service agreement with the Institute of Building Technology and Safety (IBTS), for building plan review and building inspections for the construction of the Stoney Creek Hotel and Conference Center. He said IBTS was a nonprofit organization working in conjunction with the Indian Nations Council of Government (INCOG), to identify opportunities to assist Broken Arrow and surrounding communities to streamline government projects, reduce risk for non-compliance, and free up valuable budgetary resources. Mr. Skates said this agreement would produce the reviews and inspections expeditiously and allow City inspectors to work on other projects. He added that the City would maintain the role of Project Manager.

Councilor Parks asked if IBTS would be prepared to make modifications to meet Broken Arrow's code requirements. Mr. Skates replied yes and he explained that IBTS had been provided with the City's relevant ordinances and codes as well as assuring Council that that IBTS had expertise in the code.

Councilor Mike Lester noted that in the agreement the inspection times were allowed to vary up to three days. Mr. Skates assured the Council that the Inspector would be available on a daily basis or as needed for this special project.

Director of Human Resources, Mr. Russell Gale, said in 2008 the City Council adopted a Park Master Plan which included a community park in the southwest quadrant of the

City. He said in 2011 the public approved a General Obligation Bond to acquire land in the southern part of Broken Arrow and initiate the development of a park.

Mr. Gale said discussions with the Superintendent of Broken Arrow Public Schools, Dr. Jarod Mendenhall, considered the possibility of a mutually advantageous exchange of property between the School District and the City as Dr. Mendenhall expressed a need for an Elementary School in east Broken Arrow. He said presently the School District owns fifty acres of undeveloped land immediately north of Aspen Creek Elementary School and the City had a lease purchase agreement to ultimately acquire thirty nine acres of the northern most part of the Chisolm Trail. Mr. Gale said these two properties, if exchanged, would produce mutual benefits. He said the item before the Council was a Memorandum of Understanding which authorizes the parties to enter into negotiations for a transaction or series of transactions to effectuate the transfer of properties.

Councilor Mike Lester said that this arrangement would support his goal to establish a park in that area of the City and he expressed appreciation for the efforts of both Mr. Gale and Dr. Mendenhall.

Councilor Johnnie Parks and Mayor Thurmond expressed their support as well.

12. Remarks and Inquiries by Governing Body Members

Mayor Thurmond reminded everyone that this was Breast Awareness Month. He said that it was important that those we all know and care about get their exams; it can save their life.

Mayor Thurmond recognized the new City Manager Mr. Michael Spurgeon, saying that he and the Council were very happy that he was here. He said that Mr. Spurgeon's enthusiasm and passion for the City had already been demonstrated. The Councilor's each expressed similar sentiments.

13. Remarks by City Manager

Mr. Spurgeon said, at this his first meeting, he wanted to thank the Council for the opportunity to serve as City Manager. He addressed the Citizens and Business owners saying Broken Arrow was a great community and serving as their City Manager was truly an honor. Mr. Spurgeon thanked the Directors and the staff for the warm welcome as well as members of the community that had been generous with their time and information about the City. Mr. Spurgeon said he wanted to demonstrate to the Council, the Staff and the Community that he has committed to remain in service to provide the needed continuity of leadership and stability.

Mr. Spurgeon said he had spent considerable time surveying the inner workings of the City and over the next three or four months he planned to continue to learn how City Staff serves the Citizens because that was what this is all about. He said that from what he had observed there exists a very solid foundation in every single Department.

Mr. Spurgeon said he was focused on two high priority issues: the renewal of Vision 2025 and Bond sales for project fulfillment.

He said the renewal of Vision 2025 and the provisions for its propositions would be on the November 10, 2015 ballot. Mr. Spurgeon said it was most important that the citizens receive the public education they need to make an informed decision. He said that with the help of Staff and the Communications Director, Ms. Krista Flasch, number videos have been planned for the month of October.

Mr. Spurgeon said the second priority issue was the need for Bond Sales. He said the Bond money was required to complete the projects that were identified in 2011 and 2014 and he promised Council recommendations on how to move forward with the projects that the voters had approved.
