for a period of not more than 12 MONTHS FROM THE START OF CONSTRUCTION. This grant of temporary right to use and occupy is given for the purpose of permitting the City of Broken Arrow, its employees, representatives, agents, and/or persons under contract with it, to use said described property for construction of the roadway improvements.

That the Owner(s) agree that this temporary construction easement shall be binding upon their heirs, executors, administrators and personal representatives during the term hereof and further agree that in the event the premises covered by this temporary construction easement are sold, assigned or conveyed, that the purchaser or grantee thereof will be advised of the existence of this temporary grant and that said sale during said term shall be made subject to the rights herein given.

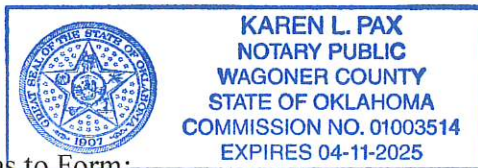

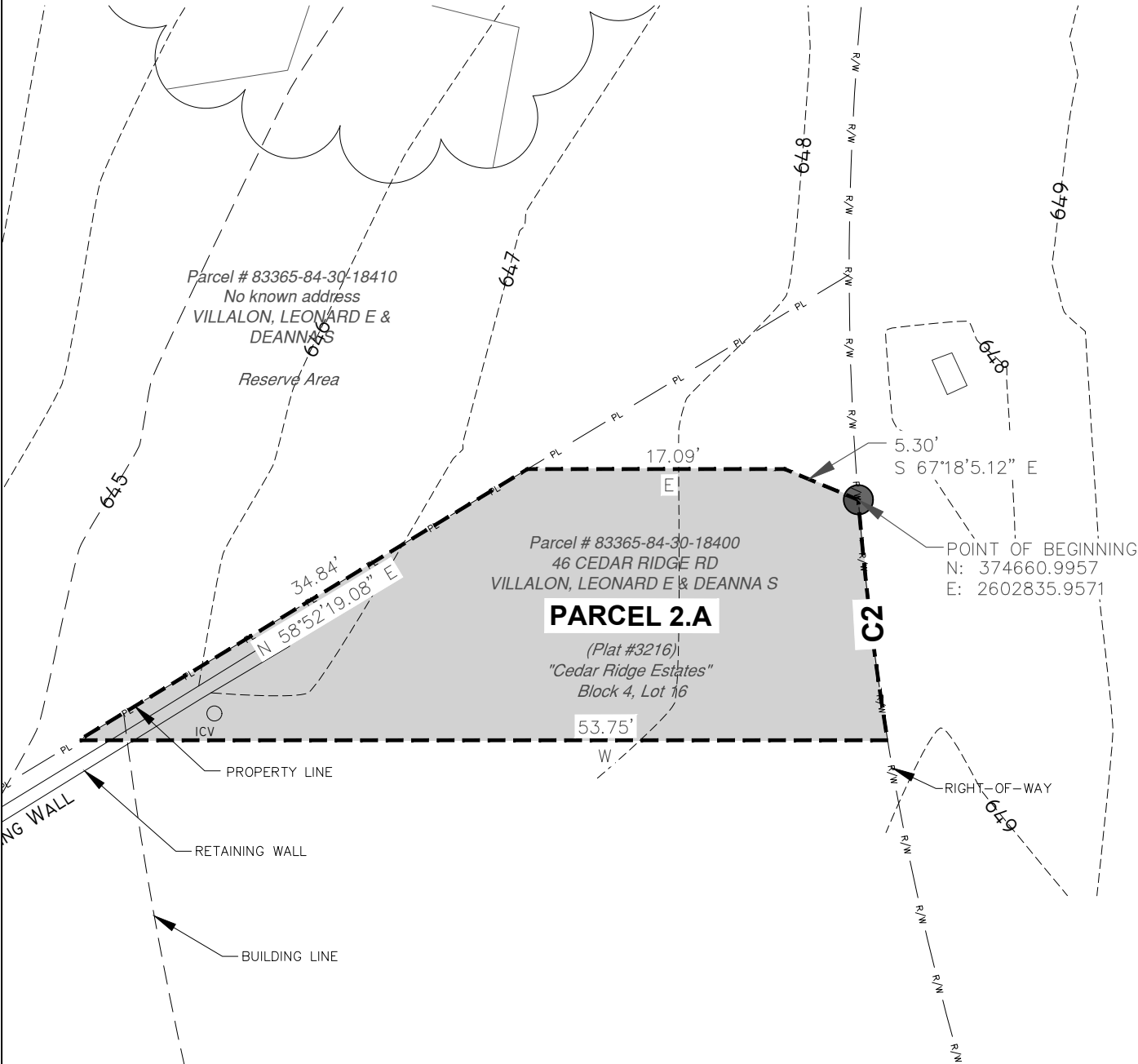
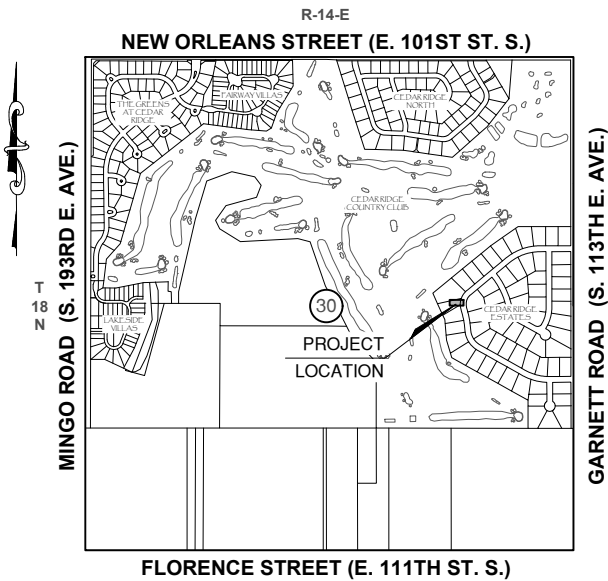

LEGAL DESCRIPTION:

A TRACT OF LAND THAT IS PART OF THE NORTHEAST QUARTER SECTION OF SECTION THIRTY (30), TOWNSHIP EIGHTEEN (18) NORTH, RANGE FOURTEEN (14) EAST OF THE INDIAN BASE AND MERIDIAN, TULSA COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE UNITED STATES GOVERNMENT SURVEY THEREOF, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT THE POINT OF BEGINNING WITH A NORTHING OF 374660.9957 AND A EASTING OF 2602835.9571; THENCE SOUTHWESTERLY ALONG THE RIGHT-OF-WAY WITH A CURVE TO THE RIGHT, WITH A RADIUS OF 192.16' FEET, WITH A CHORD BEARING OF SOUTH 06°56'59.45" WEST, WITH A CHORD DISTANCE OF 16.08' FEET TO A POINT OF CURVATURE; THENCE DUE WEST A DISTANCE OF 53.75' FEET TO A POINT ON THE SOUTH PROPERTY LINE THENCE NORTH 58°52'19.08 EAST ALONG SAID PROPERTY LINE A DISTANCE OF 34.84' FEET; THENCE DUE EAST A DISTANCE OF 17.09' FEET; THENCE SOUTH 67°18'05.12: EAST A DISTANCE OF 5.30' FEET TO THE POINT OF BEGINNING OF SAID TRACK OF LAND.
