**RE: Annual Rate Adjustment**

Dear Lee:

In accordance with our agreement with the City of Broken Arrow (BAMA), Waste Management will increase your acceptable waste/construction and demolition rate at Quarry Landfill from \$23.44 per ton to \$24.22. The rate for wastewater treatment plant sludge will increase from \$26.64 per ton to \$27.53. The \$1.25 per ton State flow fee will be in addition to the tonnage rate and all rates will be effective 7/1/19. This increase reflects an increase of 3.34% based on the annual change in the Water Sewer and Trash Collection Consumer Price Index (attached).
