THIS AMENDMENT NO. 1, made and entered into this 18th day of July 2023, by and between the CITY OF BROKEN ARROW, OKLAHOMA, a municipal corporation of the State of Oklahoma, hereinafter referred to as "CITY", and R. L. Shears Company, P.C., hereinafter referred to as "ENGINEER";

WITNESSETH:

WHEREAS, CITY and CONTRACTOR entered into an Agreement dated June 15, 2022 "ORIGINAL AGREEMENT" for services as set forth in said Agreement; and

WHEREAS, said ORIGINAL AGREEMENT requires CONTRACTOR to prepare construction documents for bidding purposes for the Central Park Garden Improvements that includes the design and construction details for the addition of a public garden.

WHEREAS, CITY and CONTRACTOR propose to amend said ORIGINAL AGREEMENT to expand the project scope and compensation to include preparation of the construction documents for the Central Park Garden Improvements.

WHEREAS, the ORIGINAL AGREEMENT and Amendments No. 1 through No. 1 shall hereinafter collectively be referred to as the "Agreement"; and

WHEREAS, funding is now available for said additional services; and

WHEREAS, CONTRACTOR is prepared to provide said additional services identified in this Amendment.

NOW THEREFORE, in consideration of the promises contained herein, the parties hereto agree to amend the Agreement as follows:

1. PROJECT SCOPE.

This Amendment requires CONTRACTOR to provide construction documents for the garden improvements to the Central Park including Title Sheet, General Pay Quantities and Notes, Site Plan, Layout and Grading Plan, Fountain Plans and Details, Planting Plans, Irrigation Plans, Planting Specifications, Irrigation Specifications, Paving Specifications, Estimate of Probable Cost.

2. CHANGE IN CONTRACT AMOUNT.

As compensation for the additional work, CITY shall pay CONTRACTOR in accordance with the terms as a change in the contract amount;


