Environmental Division Manager Emily Rowland reported this was to award the construction contract for the sewer line going through Events Park. She explained this was one of the oldest sewer lines in the Broken Arrow system and the Utilities Department was excited to get this replaced.

**B. 24-893 Consideration, discussion, and possible approval of award of the lowest responsible bid to TimberWolf Excavating, LLC and authorize execution of a construction contract for the Florence and Haikey Creek Sewer and Waterline Rehabilitation (Project No. WL23050)**

Ms. Rowland explained this project was for two water line crossings and one sewer line crossing; two of which were on Florence between Garnet and Olive, and one was across from the dog park on 101<sup>st</sup>. She discussed why these needed to be replaced to prevent flooding in the future.

Trustee Lisa Ford asked if this would interfere with the potential raising of the intersection at 101<sup>st</sup> and Garnet.

Assistant City Manager of Operations Kenny Schwab noted it should not, because it was several hundred feet east of the intersection, but in regard to the intersection, he understood Tulsa County planned to begin this fall.

Vice Chair Christi Gillespie noted the intersection project has been “about to begin” for quite some time now.

Trustee Ford agreed.

City Manager Spurgeon stated he would have Mr. Schwab provide an update regarding the intersection to the Trustees. He stated he believed Tulsa County had the funding in place to do the work, but there were approvals needed in order to be able to release the construction contract. He stated Tulsa County was closer than it had ever been to beginning the project.

Mr. Schwab stated from what he heard, Tulsa County had approval and the funding, but was waiting for approval from FEMA. He stated Mr. Alex Mills indicated FEMA would issue approval by Labor Day.
