20' WIDE WATERLINE EASEMENT VACATION LEGAL DESCRIPTION:

A TWENTY (20) FOOT WIDE TRACT OF LAND THAT IS PART OF LOT ONE (1), BLOCK ONE (1), EVERGREEN BAPTIST CHURCH AMENDED, AN ADDITION TO THE CITY OF BROKEN ARROW, TULSA COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT THEREOF, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT 1, BLOCK 1;
THENCE SOUTH 88°48'39" WEST ALONG THE SOUTH LINE THEREOF 311.80 FEET;
THENCE NORTH 01°02'12" WEST AND ALONG THE WEST LINE OF A PLATTED WATERLINE EASEMENT 660.94 FEET;
THENCE NORTH 46°04'17" WEST 349.80 FEET;
THENCE NORTH 90°00'00" WEST 2.96 FEET;
THENCE SOUTH 44°04'00" WEST 6.00 FEET TO THE POINT OF BEGINNING;

THENCE CONTINUING SOUTH 44°04'00" WEST 168.48 FEET;
THENCE SOUTH 66°57'28" WEST 10.64 FEET;
THENCE SOUTH 45°55'28" WEST 364.58 FEET TO A PLATTED WATERLINE EASEMENT;
THENCE NORTH 46°02'12" WEST ALONG SAID PLATTED EASEMENT 20.01 FEET;
THENCE NORTH 45°55'28" EAST AND DEPARTING SAID PLATTED EASEMENT 368.98 FEET;
THENCE NORTH 66°57'28" EAST 10.31 FEET;
THENCE NORTH 44°04'00" EAST 164.43 FEET;
THENCE SOUTH 45°56'00" EAST 20.00 FEET TO THE POINT OF BEGINNING.

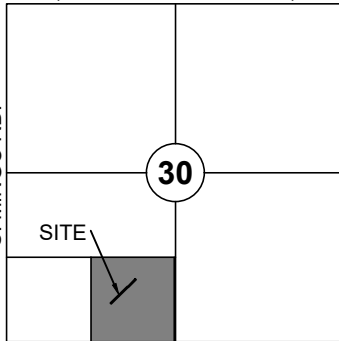
