PROFESSIONAL CONSULTANT CONTRACT

The City of Broken Arrow, an Oklahoma Municipal Corporation (City) and Tulsa Engineering & Planning Associates, Inc. (Consultant) with the principal place of business located at 9820 East 41st Street South, Suite 102, Tulsa, Oklahoma 74146, hereby enter into the following Contract:

The Assistant City Manager - Operations representing the City desires to employ the professional services of the Consultant to provide a 3D survey of the existing Tiger Hill wall outlined in the work plan.

The Consultant shall perform all duties, responsibilities and requirements set out in the Professional Services Contract for providing a 3D survey of the existing Tiger Hill wall located at the southwest corner of Kenosha Street (71st St. So.) and 9th Street (177th E. Ave.) intersection, attached hereto and made a part hereof.

These duties, responsibilities and requirements shall begin upon the execution of this Contract and shall be completed within twenty-one (21) calendar days.

It is agreed that the Consultant shall be compensated at on an hourly not to exceed basis (contract shall not exceed Twelve Thousand Five Hundred Forty and No/100 Dollars (\$12,540.00)) for the entire Scope of the Professional Services rendered. The Consultant shall submit invoices, requesting payment for services rendered, monthly to the Engineering Division Manager in accordance with the progress of the work. The invoices shall be in a format satisfactory to the Engineering Division Manager. Payment will be made following the first eligible City Council meeting occurring after the date on the invoice.

The Consultant agrees that this professional service shall be treated as an important service to the City and also agrees to commit the time necessary to perform the professional services in a professional manner.

The parties agree that the Consultant's position is not a traditional City employee position, therefore the foregoing constitutes all the benefits and other forms of compensation due the Consultant, acting in the role of an independent contractor, and therefore ineligible for all other benefits paid to regular full-time City employees. The Consultant agrees to abide by and comply with all of the City's Administrative Policies.

The Consultant shall acquire all insurance policies required for professional liability insurance, auto insurance, and/or health insurance. The Consultant shall be responsible for his own vehicle expenses and any other indirect costs incurred in fulfilling the stated contract requirements.

The foregoing Professional Services Contract supersedes all previous negotiations and may

not be modified except by a written order executed by the parties hereto.

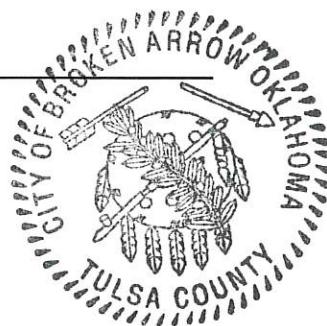

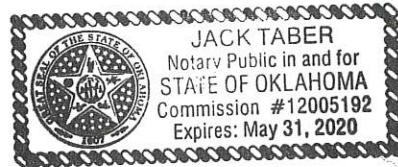

**SPECIAL PROVISIONS
PROJECT NUMBER 171703**

SP - 1.0 SCOPE OF THE PROJECT:

1.1 Project Name. Professional surveying services for providing a 3D survey of the existing Tiger Hill wall located at the southwest corner of Kenosha Street (71st St. So.) and 9th Street (177th E. Ave.) intersection in the City of Broken Arrow.

SP - 2.0 SERVICES OF THE CITY: THE CITY WILL:

- 2.1. Furnish to Consultant all data in its possession, and needed engineering guidance as necessary for the service provider to complete the contract requirements.
- 2.2. Designate in writing a person to act as its representative in respect to the work to be performed under this agreement. Such person shall have complete authority to transmit instructions, receive information, interpret and define the City's policies and decisions with respect to materials, equipment, elements and systems pertinent to the services covered by this agreement.

SP - 3.0 SCOPE OF SERVICES: THE CONSULTANT SHALL:

- 3.1 The Consultant will perform necessary field work to provide a baseline survey in the form of a 3D scan and photograph of the existing Tiger Hill modular block wall and surrounding area. In addition, the consultant shall set eight (8) control points for use during the initial scanning phase and during future scanning in order to detect movement of the wall over time.
- 3.2 The consultant shall provide the following deliverables:
 - 3.2.1 A finished survey will be provided along with an AutoCAD point cloud with embedded photo. AutoCAD file shall be 2018 format.
 - 3.2.2 All field notes relevant to work shall be provided.
 - 3.2.3 Photographs of the existing site shall be provided.
 - 3.2.4 A CSV file of points and coordinates shall be provided.
