**Description**

A TRACT OF LAND THAT IS A PART OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER (SE/4 SE/4) OF SECTION FIVE (5), TOWNSHIP EIGHTEEN (18) NORTH, RANGE FOURTEEN (14) EAST OF THE INDIAN MERIDIAN, TULSA COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE U.S. GOVERNMENT SURVEY THEREOF, SAID TRACT BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

SAID TRACT CONTAINS 428,390 SQUARE FEET OR 9.834 ACRES.

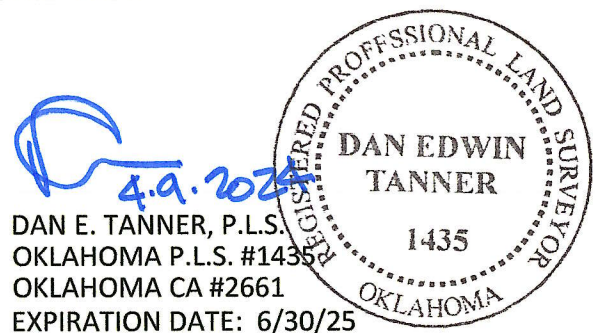
**Basis of Bearing**

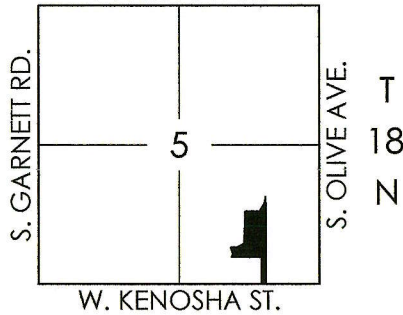

  - (2) 1" IRON PIN FOUND AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER (SE/4) OF SECTION 5;
- THE BEARING BETWEEN SAID MONUMENTS BEING NORTH 1°24'22" EAST.

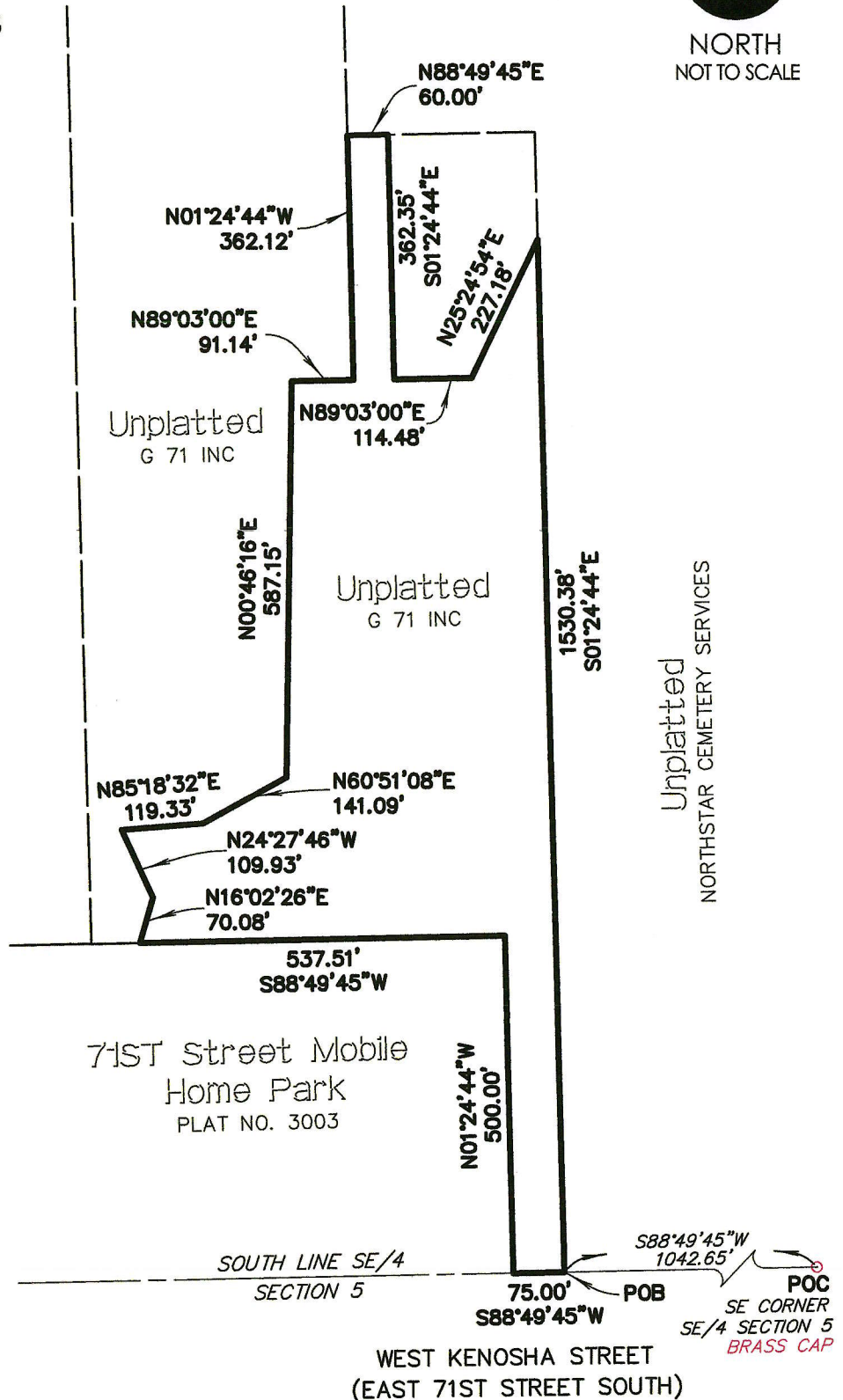


Location Map
