AMENDMENT NO. 1 TO ICE CHALLENGE ENTERPRISES, LLC 2017 PROMOTIONAL LICENSE

This AMENDMENT NO. 1, made and entered into this day of January 2018, by and between the CITY OF BROKEN ARROW, OKLAHOMA, a municipal corporation of the State of Oklahoma, hereinafter referred to as "CITY" and ICE CHALLENGE ENTERPRISES, LLC hereinto after referred to as "Ice Rink Operator".

WITNESSETH:

WHEREAS, CITY and Ice Rink Operator entered into an Agreement dated September 5th, 2017 for services as set forth in said Agreement; and

WHEREAS, said Agreement allows the Ice Rink Operator to operate an outdoor ice rink at the City's Rose District Plaza and Pavilion; and

WHEREAS, CITY and Ice Rink Operator propose to extend the term of said Agreement; and

NOW THEREFORE, in consideration of the promises contained herein, the parties hereto agree to amend the Agreement as follows:

1. This Agreement term shall take effect November 8th, 2017 and end February 28th, 2018. This Agreement can be renewed for two additional terms from the beginning of November to the end of February in successive years, by being renewed in writing by the Ice Rink Operator and acknowledged by the City by the first day of April following the end of each term. In consideration of the City making this property available for an outdoor ice rink the Ice Rink Operator will provide the City thirty centers (\$0.30) per ticket after the first seven thousand (7,000) paid attendance and fifty cents (\$.50) on every ticket after ten thousand (10,000) until an amount not to exceed seven thousand dollars (\$7,000) is collected. Ice Rink Operator acknowledges that the fee will be due to the City within 30 days following the end of each term.

Except as amended hereby, all terms of the Original Agreement shall remain in full force and effect without modification or change.
