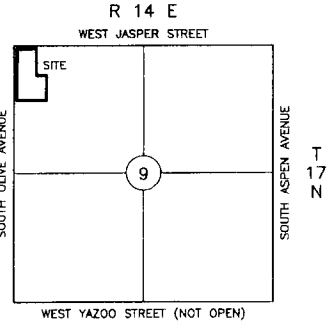
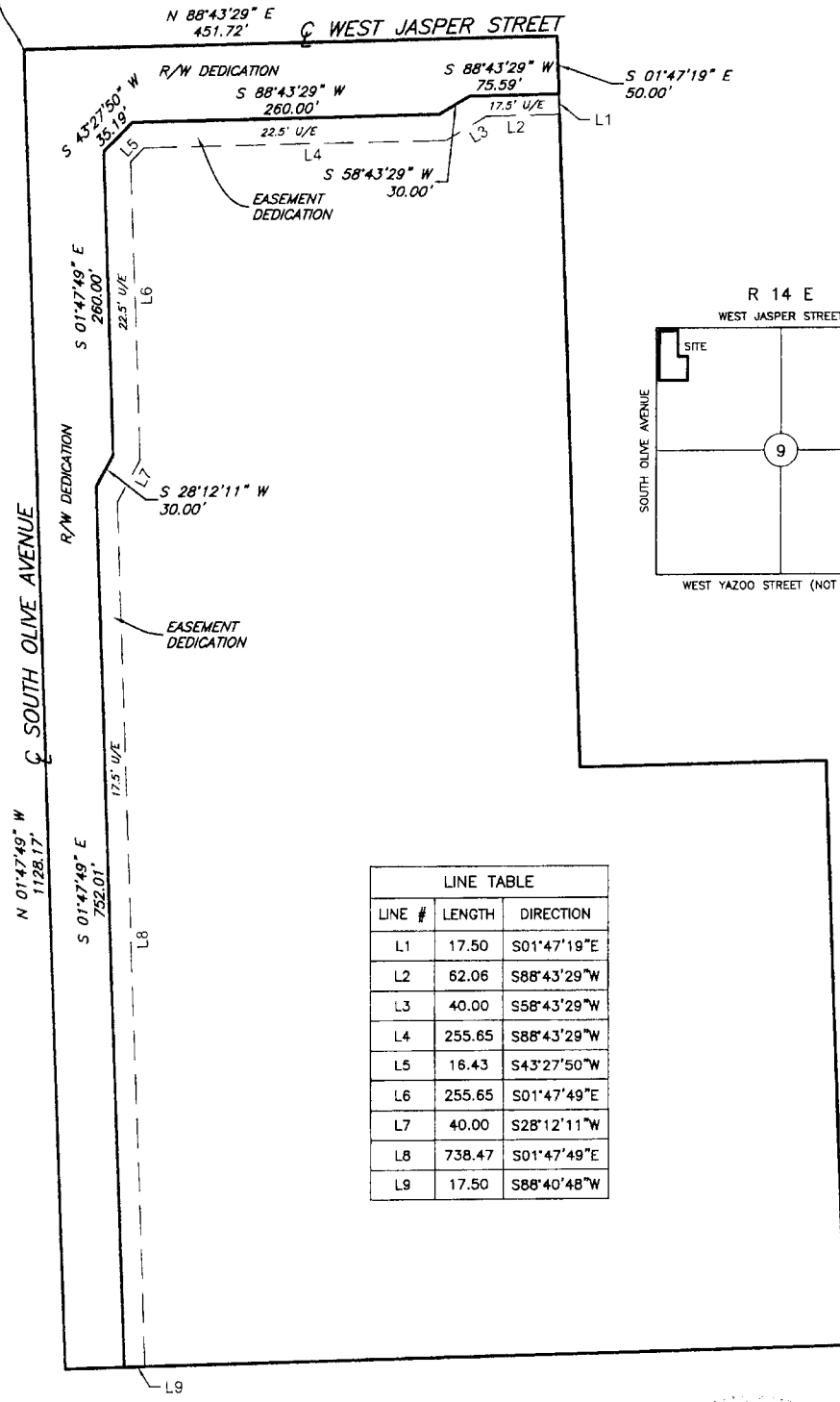


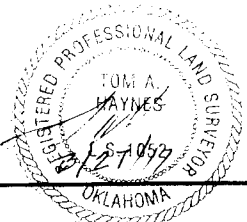
RIGHT-OF-WAY AND EASEMENT EXHIBIT
