**5. Public Hearings, Appeals, Presentations, Recognitions, Awards**

**A. 25-1207 Presentation regarding road closure of Main Street just north of the intersection with Fort Worth in association with the Old Town Waterline Improvements Projects**

Tim Robins, Utilities Director, presented Item 25-1207, planned Main Street road closure related to water quality improvements downtown. City crews will replace aging cast-iron water lines near the railroad with a new 12-inch line tied in by the farmer's market pavilion and extending east toward Houston. Work begins once the farmer's market clears that evening, with excavation completed overnight and traffic plates placed by 7 a.m. Asphalt repairs will follow in collaboration with the Streets Department, causing only minor one-lane closures during the week. The entire project will be completed in-house and wrapped up by the end of the week.

**B. 25-1172 Presentation of update of the pilot study Phase 2 for County Line Trunk Sewer Odor Control System**

Tim Robins, Utilities Director, presented Item 25-1172, an update on Phase Two of the County Line Trunk Sewer Odor Control pilot program. He explained that Broken Arrow's aging sewer infrastructure, with over 600 miles of lines and many lift stations, creates odor problems, particularly along County Line. A holistic approach has been used—biological treatments with Biochem bacteria, odor control units to let the system "breathe," and mechanical improvements at lift stations.

The Biochem solution replaces corrosive chemicals, reduces grease and hydrogen sulfide, and helps the wastewater plant remain in permit compliance. A new Wager odor control unit installed near Highway 51 in February 2024 has already eliminated odor complaints in nearby neighborhoods and reduced H<sub>2</sub>S levels, including as far as Fire Station 3. The project cost about \$175,000 plus \$15,000 annually, and future expansion is planned along County Line near New Orleans and by the new event center.

Trustees praised the in-house talent, efficiency, and cost-effective approach, jokingly commending Robins for his "passion and wisdom for passing gas." The presentation highlighted both technical success and strong teamwork.
