## **RESOLUTION NO. 1686**

A RESOLUTION OF THE BROKEN ARROW CITY COUNCIL AUTHORIZING THE CITY LEGAL DEPARTMENT TO FILE AN ACTION IN DISTRICT COURT TO OBTAIN A DECREE ORDERING THE ABATEMENT OF A PUBLIC NUISANCE REGARDING THE PROPERTY LOCATED AT 21410 EAST 38TH STREET SOUTH, BROKEN ARROW, OKLAHOMA 74014

**WHEREAS**, the property located at 21410 East 38th Street South, Broken Arrow, Oklahoma 74014, was inspected by representatives of the City of Broken Arrow who determined that the main structure in its present condition constitutes not only a menace to the health and safety of the public, but is also a public nuisance; and

**WHEREAS**, on February 26, 2025, a Notice to Abate a Nuisance public hearing letter was mailed by United States Postal Service to the owner of the property, at the address shown at the current year's tax rolls in the Wagoner County Treasurer's office, namely: Gueren Geoffrey Hunter White, 21410 East 38th Street South, Broken Arrow, Oklahoma 74014; and

WHEREAS, that the public hearing held on April 2, 2025, Norman Stephens, the Hearing Officer for the City of Broken Arrow, Oklahoma, found the structure at 21410 East 38th Street South, Broken Arrow, Oklahoma 74014, to be in violation of City Ordinance § 15-1.C.15 and 15-4, and Oklahoma State Statute, 11 O.S. §§ 22-111, 112; and

**WHEREAS**, following the public hearing on April 2, 2025, an Order of Abatement was issued finding that the structure in its present condition was a dilapidated structure in violation of City Ordinance § 15-1.C(15) and 15-4, and Oklahoma State Statute, 11 O.S. §§ 22-111, 112; and

**WHEREAS**, the above-described public nuisance remains unabated.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BROKEN ARROW, OKLAHOMA, that the main structure on the property legally described as Lot Two (2), Block Three (3), SWAN LAKE ADDITION to the City of Broken Arrow, Wagoner County, State of Oklahoma, and locally known as 21410 East 38th Street South, Broken Arrow, Oklahoma 74014, has previously been declared a public nuisance; and

**BE IT FURTHER RESOLVED** that the City Attorney is hereby authorized to file an action in District Court pursuant to 50 O.S. § 17, to obtain a Decree ordering the abatement of the public nuisance and should the owner fail to abate the nuisance as ordered, that the matter may be referred to Community Development to take all necessary action to demolish and remove said structure.
