ANY RECURRENCE OF THE VIOLATION LISTED HEREIN WITHIN SIX MONTHS AFTER THE REMOVAL OF TRASH OR CUTTING OF WEEDS/GRASS OR SECURING OF STRUCTURES MAY BE SUMMARILY ABATED BY THE CITY, AND ALL COSTS ASSOCIATED WITH THE ABATEMENT WILL BE ASSESSED AGAINST THE PROPERTY OWNER AND A LIEN MAY BE IMPOSED UPON THE PROPERTY TO SECURE SUCH PAYMENT - ALL WITHOUT FURTHER PRIOR NOTICE TO THE PROPERTY OWNER.
