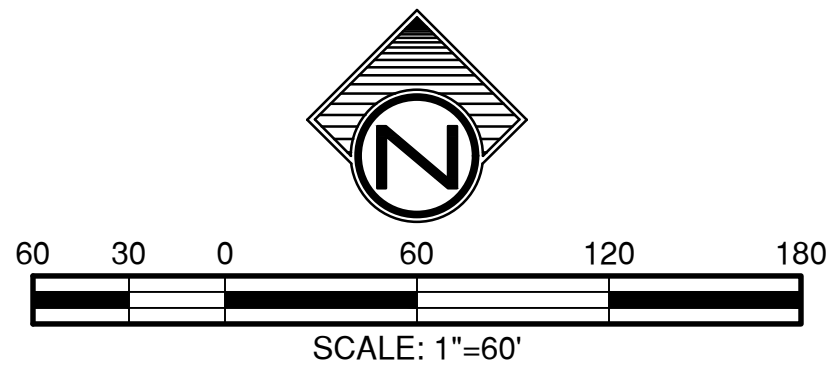
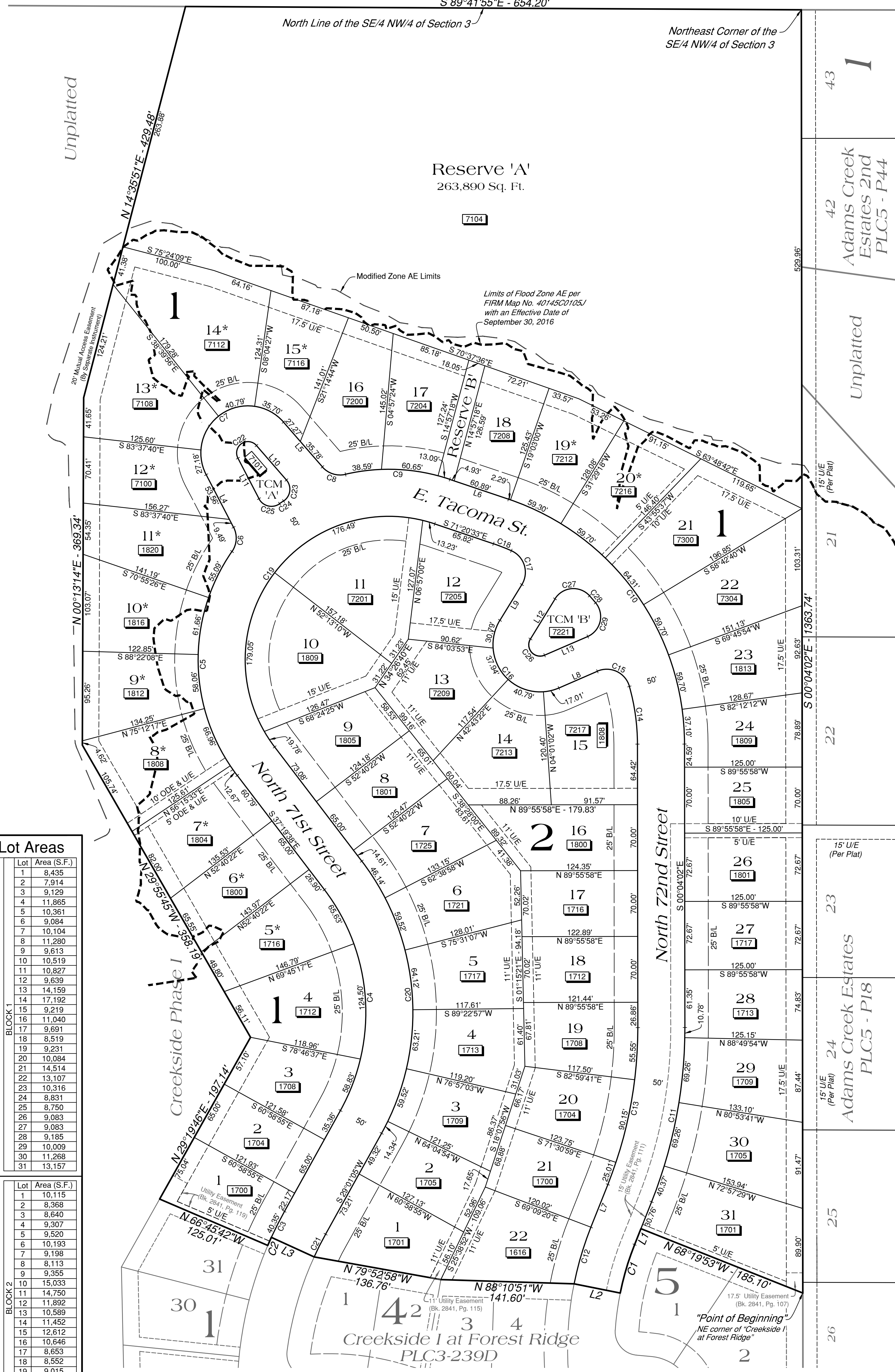
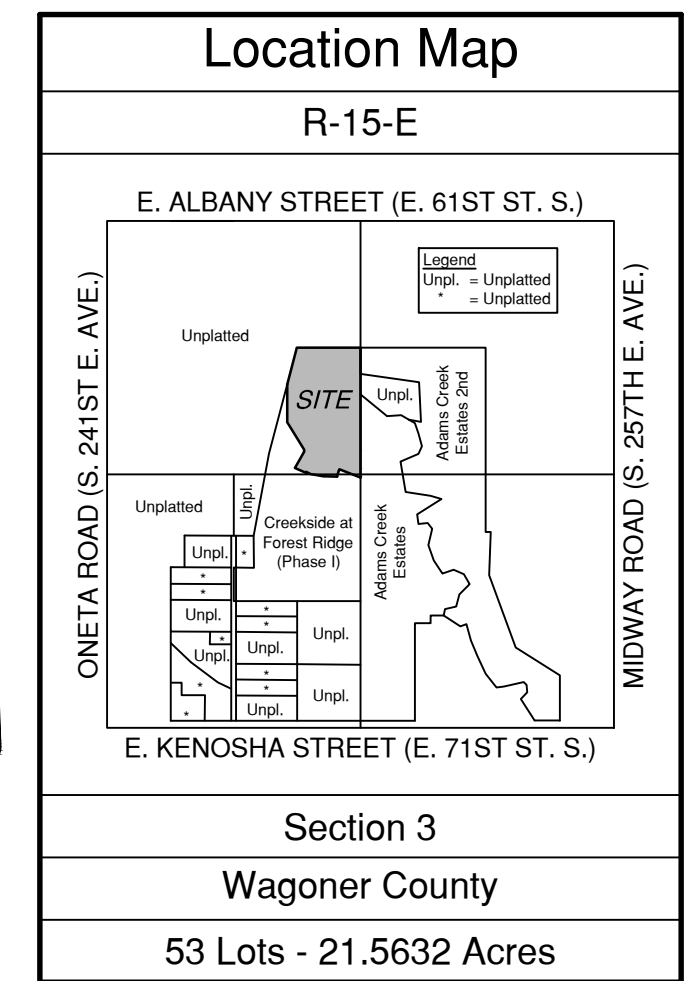


Creekside II at Forest Ridge

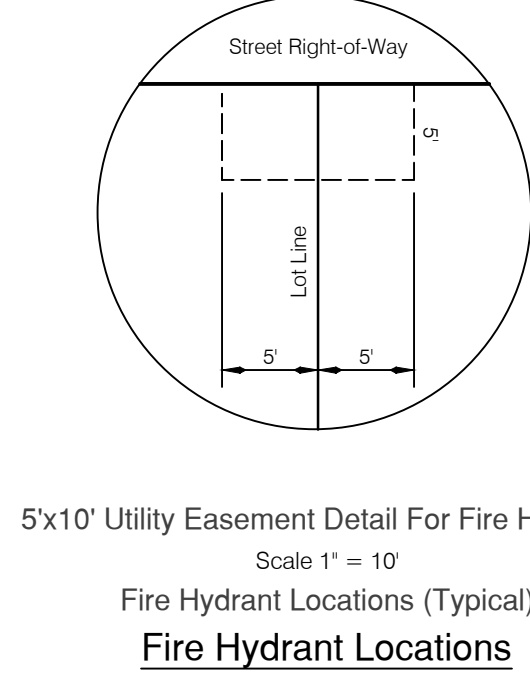
