Once approved, Roses Inc. Green Country will provide a balanced quantity of all rose varieties required to achieve the aesthetical equivalent to the preexisting rose planters.

Roses Inc. Green Country Suggests the existing contractor source and fill the top 12" of the raised rose planters with a garden variety top soil 80/20 mixture. Beneath the 80/20 mix, a Sandy lome may be used as planter filler to reduce cost of entire planter being filled with an 80/20 mixture.

Use of Soil Amendment will then be added into planters consisting of earthworm castings, bat guano, & other organic material as well as a Root Stimulant upon plant installation.
