Charlie Bright, Director of Engineering and Construction, presented the award for a 24-inch water line project in the Florence and Ninth Street area, part of the southern loop of the city's transmission system to supply water to South Broken Arrow. Collaboration with Community Development and a developer allowed the city to secure additional land for future road widening in exchange for constructing part of the developer's required water line, ensuring an equal value trade-off. The project received four bids, with Cherokee Pride Construction being the lowest bidder at \$1,906,000.
