Oklahoma Statutory Form

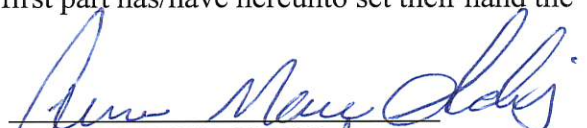

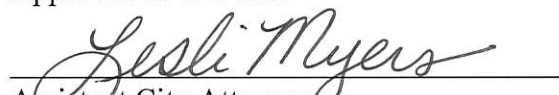

LEGAL DESCRIPTION:

A strip, piece or parcel of land lying in part of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 33, Township 18 North, Range 14 East, IM, Tulsa County, Oklahoma. Said parcel of land being described as follows:

Commencing at the Northwest corner of the NE $\frac{1}{4}$ of Section 33, thence N 88°34'36" E along the North line of said NE $\frac{1}{4}$ a distance of 1095.54 feet to the point of beginning, thence continuing N 88°34'36" E along said North line a distance of 220.00 feet, thence S 01°25'24" E a distance of 50.00 feet, thence S 88°34'36" W on a line parallel with and 50.00 feet South of said North line a distance of 220.00 feet, thence N 01°25'24" W a distance of 50.00 feet to said point of beginning..

Containing 0.13 acres (5555 Sq. Ft.) more or less, of new right of way, the remaining area included in the above description being statutory right of way occupied by the present road.

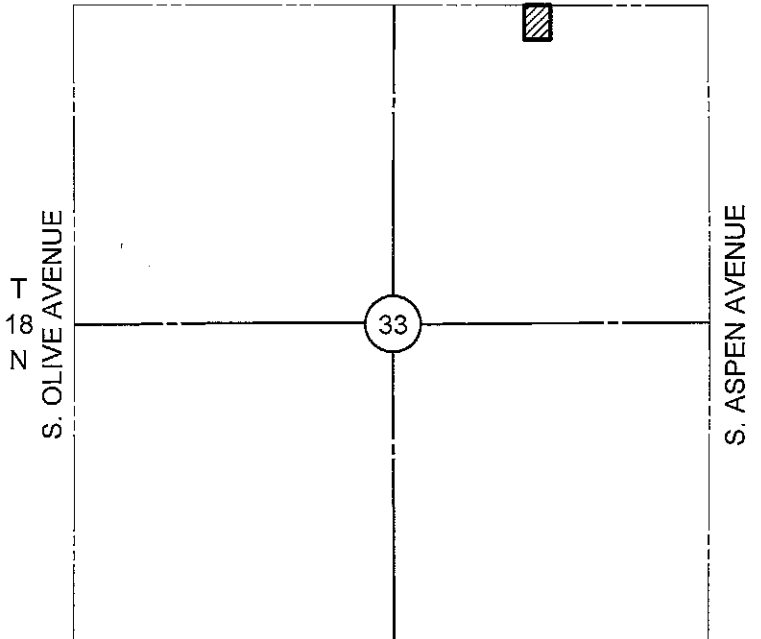

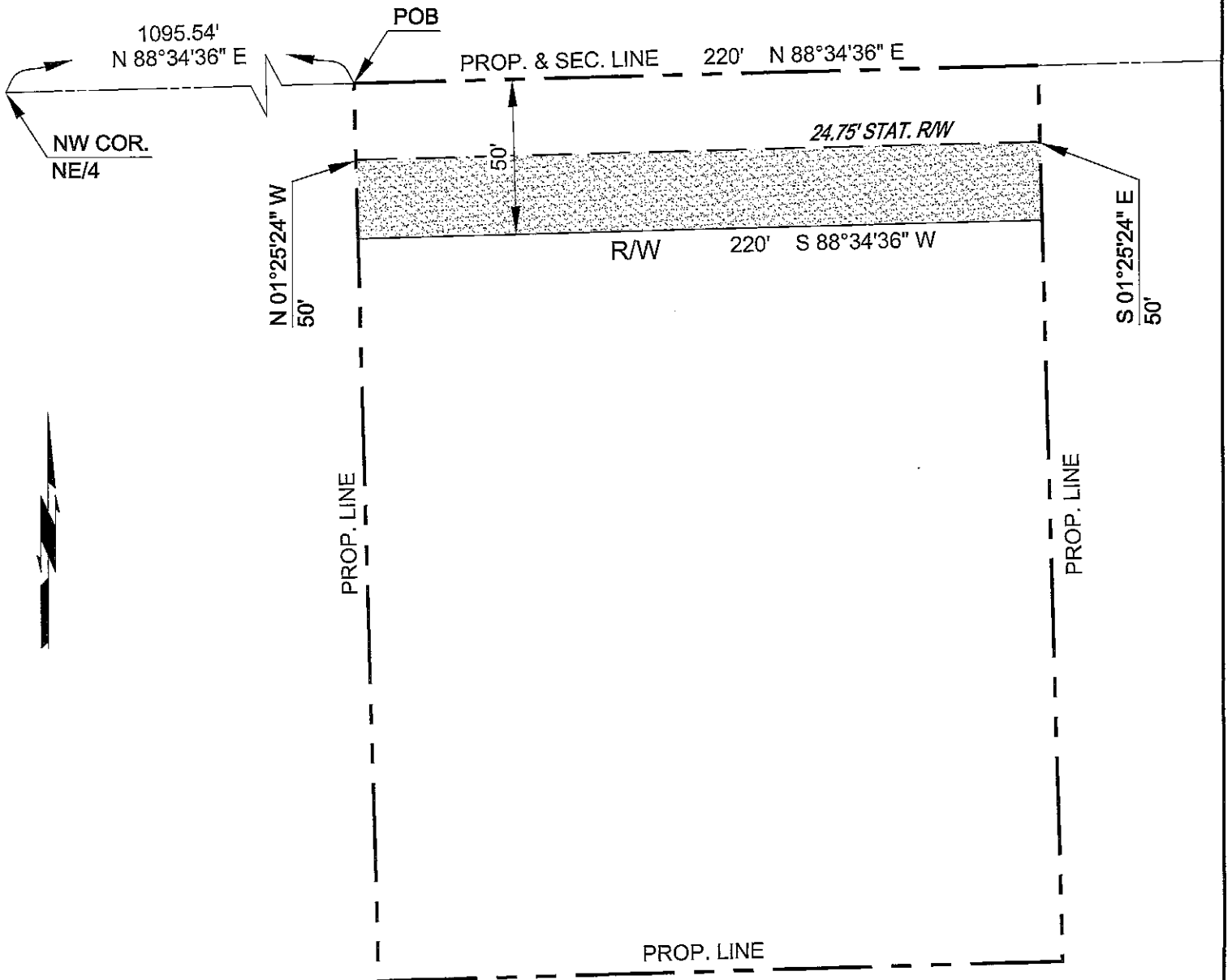
