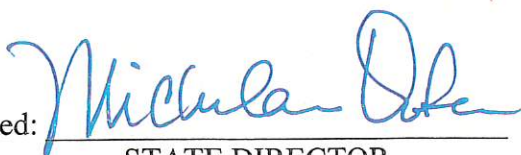

The Oklahoma Department of Emergency Management is submitting this request on behalf of the City of Broken Arrow of Emergency Management Task Force 1 for approval to purchase one Zodiac Mil-Pro FC420 LSRF Rescue Boat.

Description/Justification: City of Broken Arrow Task Force 1 unit has developed a Flood and Swift Water Boat program to support Oklahoma Task Force 1 Team during flood/swift water events. Beginning April of 2016, more than half of the 77 Oklahoma counties have been impacted by major flooding. Rescue boats were needed in the majority of these counties; which were responsible for saving the lives of citizens in need. Oklahoma Task Force 1 unit will be able to deliver training across the state and better prepare other state and local agencies in Flood and Swift Water safety. They will also have the ability for rapid intervention during immediate needs of flooding across the state and to coordinate efforts during these types of incidents or disasters to improve safety and operational readiness in Oklahoma.

The Oklahoma Task Force 1 unit's most recent event affecting many citizens in Oklahoma was the flash floods of November 2017. Another recent incident was the September 2017 EMAC request from Texas to assist with water rescue in the Houston Texas area. Teams from Oklahoma rescued many of the local citizens trapped by flood/swift water.
