8. Citizens' Opportunity to Address the Council on General Topics

Mr. Richard Pisaturo of Broken Arrow addressed the Council on the subject of continuing issues with commercial vehicles that were being parked on the neighborhood streets in the Wolf Creek Subdivision. He said that three different commercial vehicle owners had been cited as many as six times each. He said there was no system in place to escalate the citations. He gave an example of the distance between two commercial vehicles showing that fire trucks would only have a twelve inch easement to pass between the vehicles.

No Action was required or taken.

9. General Council Business

A. 15-246 Consideration, discussion and possible approval of Resolution No. 888, a Resolution approving the Fiscal Year 2015-2016 Manual of Fees, establishing fees and costs charged by the City of Broken Arrow; authorizing the periodic adjustment of these fees by the City Manager; and providing an effective date of September 1, 2015

City Attorney, Ms. Beth Anne Wilkening, reminded the Council that last year was the

first year that the Manual of Fees was utilized. She said the purpose behind the manual was to collect all the fees that had been located in all the Ordinances and put them in one place. Ms. Wilkening said the intended result was to provide a more citizen friendly access to all fees for various services provided by the City. She said that the plan had been to return annually to Council to make adjustments. Ms. Wilkening drew the Council's attention to the utility rate increases that had been discussed during the budget review. She said the 2016 Manual of Fees included a water rate increase of ten percent, a sewer rate increase of twelve percent, and a stormwater rate increase of five percent. Ms. Wilkening said that the Manual of Fees would go into effect on September 1, 2015. She said the rate increases would be reflected on the October billing cycle. Ms. Wilkening said the LifeRide charges would also be reflected in the Manual of Fees along with various services fees. She said that it was originally contemplated that the fees be tied to the price index or some other appropriate index that would allow for inflation, however, that was not done this year due to the recommendation of the Fiscal Sustainability Committee.

B. 15-339 Consideration, discussion and possible approval of submitting an application to the Tulsa County Vision Authority for Vision 2025 funding for improvements in the Rose District and Central Park

Acting City Manager, Mr. Russell Gale, reminded the Council that in November of 2014 the Tulsa Vision Authority determined that there would be \$45,000,000.00 in excess Vison 2015 sales tax receipts and that the Broken Arrow share of that excess would be approximately \$19.6 million. He said those funds would be broken down into three project categories. Mr. Gale said that earlier this year the City submitted an application that was approved for a contract that would utilize the proposition 3 funds totaling, \$7.1 million, for improvements and the construction of the Stoney Creek Conference Center. He said proposition 4 is funding that can be used for capital related to community enrichment which totals approximately \$3.7 million. Mr. Gale said that it was staff's recommendation that roughly \$11.2 million of the proposition 4 funding be used for improvements in the Rose District which includes the following improvements

- 1. Rose District Gateway at Kenosha and Main Street \$250,000
- 2. Zero Grade Fountain at the Farmer's Market \$750,000
- 3. Streetscapes from Dallas south to Ft. Worth and College north to Detroit \$3,000,000
- 4. Architectural Services for the design of the BA Creative Arts Center \$650,000
- 5. Enhanced Special Event Electrical Distribution System at Central Park \$300,000
- 6. Intersection improvements at Ash and El Paso \$50,000

Mr. Gale said these improvements would total an estimated \$5,000,000. He said staff proposed that the City apply for \$3,687,500 in Vision 2025 funds to assist in the completion of the improvements. He added that in next month's Council meeting there would be a proposal to approve the sale of \$1.3 million in General Obligation Bonds that the public approved in 2014. Mr. Gale said construction is estimated to begin soon after the first of 2016.

Assistant City Manager, Mr. Jeff Jenkins, gave the Council an overview of the functions and objectives of the Employee Advisory Committee (EAC) as outlined in the fact sheet for this item. He said in the interest of promoting productivity the EAC recommended, through the Idea of the Month program, to add Christmas Eve to the approved list of city holidays. He said the recommendation was based on the following points:

- 1. A survey of eleven cities throughout the State of Oklahoma found that a majority had Christmas Eve as an approved holiday
- 2. Low call volumes on Christmas Eve
- 3. Overall little to no impact upon customer service

Mr. Jenkins told the Council that the proposed holiday was approved by the Acting City Manager. He said this change would require the Legal Department to add this holiday to Section 2-151(e) of the Broken Arrow Code and for the Council to adopt these changes in the amended Ordinance. The Council expressed their approval of this idea as appropriate and deserving for the City staff.

Ms. Wilkening said on August 4, 2015 the Council approved the Amended Legal Notice of Annexation that was then published as required law and followed by legal mailings of notification. She said the annexation regarded a track of land that was undeveloped and zoned agricultural. Ms. Wilkening said the plan was to demolish any current structures on the property and have the property rezoned to heavy commercial. She said a public hearing would be held at the next Council meeting regarding the development of this property and rezoning would be established with the Ordinance up for adoption at the time.

Ms. Wilkening said that typically when the Council adopts Ordinances for General Obligation Bond issues the Ordinances are not set for preview; they are sent directly for adoption. She said that in this case, because this will be the first sales tax initiative since 1979, the Acting City Manager thought it would be prudent to put it on for preview. She said she had submitted her draft to the Bond Counsel and comments had been received and reviewed. Ms. Wilkening said that while it was thought that representing the initiative in terms of pennies would have been clearer to the public, the Bond Counsel required the initiative be expressed in percentages. Ms. Wilkening reviewed the specifics of the Ordinance. She explained that the Ordinance would create a public safety fund and would be separate from the General Fund. Ms. Wilkening said the Ordinance would be subject to the approval of the majority of the voters and would become effective on the first day of January 2017 if it were approved. She said the purpose of the fund would be for increasing personnel in the fire and police departments, as well as provide for safety equipment and vehicles. She said it had been drafted in such a way as to allow this Council and future Councils the latitude to apply to the funds to the best use.

Councilor Scott Eudey said the he preferred the amount of the initiative expressed as a percentage of a penny and ask if that could also be included in the Ordinance. Ms. Wilkening said that the Bond Counsel required that the increase be expressed the format of tax percentage but that the penny amount could be used in the materials provided to the public.

Councilor Mike Lester asked for clarification of the term "Bond issue" used during the discussion saying that this item was a sales tax. Ms. Wilkening corrected the language used in the discussion saying that indeed it was a permanent sales tax initiative that was the subject of the Ordinances under preview.

Councilor Johnnie Parks asked for clarification saying regardless of how the Ordinance was structured for police or fire or what flexibility was intrinsic in the Ordinance, all of the funds would be dedicated to public safety. Ms. Wilkening confirmed that was true.

Ms. Wilkening said this item was a sales tax initiative for road repairs and the improvement of traffic conditions in the City. She said the original intent of the initiative had been to provide general repairs to existing streets but the Bond Counsel recommended that the Ordinance be written in fairly broad terms because there could be unforeseen circumstances, such as severe weather, that could impact the type of repairs that roads might require. She added that pursuant to a public meeting there were suggestions to add public sidewalks and that needed to be accommodated and then references to stormwater were determined to be necessary as during street repairs stormwater elements are often integral.
