1. Call to Order

4. Consideration of Items Removed from Consent Agenda

5. General Board Business

A. 17-1623 **Consideration and possible approval for a new detached garage, located at 218 E. El Paso Street, between Second Street and Third Street, Lots 17, 18, and the west 12 feet Lot 19, Block 57, Original Township of Broken Arrow**

Development Services Director, Michael Skates presented this item. City staff worked with Dan Merkey to discuss the opportunity to build a detached garage on his property. Mr. Skates stated the lot combo would be going to the Planning Commission Thursday, January 12, 2017. At that time, if the Planning Commission approves Mr. Merkey's request, Mr. Merkey can proceed with the detached garage. Mr. Skates stated the design of the detached garage is in conformance of the properties adjacent to this location. Mr. Merkey intends to have electric on the existing house meter at a later time. Chairperson Ernest Redwine inquired about the regulation that says a percentage of garage doors facing the street shall comprise no more than 40% of the total length of a dwelling façade. Mr. Redwine asked if it applied in this situation. Mr. Skates stated it does not apply in this instance as the main concern was to join the two properties. Additional landscaping will be added in the future.

B. 17-1622 **Presentation and discussion of 2017 Comprehensive Plan updates**

Development Services Director, Michael Skates presented the 2017 Comprehensive Plan update. The Comprehensive Plan is a master plan that guides development with the City of Broken Arrow. The last update to the Comprehensive Plan was completed in 1997 and a partial amendment was completed in June 2003. City Staff thoroughly reviewed the Comprehensive Plan in 2016 and have identified items to be included in the future Comprehensive Plan updates. Current technology updates may be included in future updates. City Staff has identified a timeline with the next step to prepare a proposal with the City of Broken Arrow Engineering Department to advertise February 2017 to hire a consultant to assist with the Comprehensive Plan update.

Member Lee Whelpley inquired if the Comprehensive Plan is a 20-year plan. Mr. Skates confirmed that the City's Comprehensive Plan is a 20-year plan. Projects within the plan have been separated into segments to allow for funding of projects to be completed over several fiscal budgets. Mr. Skates stated the update process may take up to three years to complete. The proposed update would essentially be in place from years 2020 to 2040.

Chairperson Ernest Redwine inquired about an update regarding the overlay district. Member Greg Graham inquired how the residential overlay fits into the Comprehensive Plan update discussion. Mr. Skates stated there are no new updates regarding the overlay district at this time. Mr. Skates stated the City's Special Projects Manager is currently working on updating this information and will present to the Downtown Advisory Board at a later date.

Economic Development Coordinator, Norman Stephens introduced Cody Mosely to the Downtown Advisory Board. Mr. Mosely stated he has met with City Staff and is excited about the growth of the Rose District.
