Brief Project Description: Center for Arts, Innovation and Creativity

This project consists of the construction of: a two story new building on Main Street in the Rose District and is intended to be a gathering place for local artists and the general public. It is anticipated that in Phase One the Center will include a lobby/gallery exhibit hall, a gift shop, a catering kitchen, a film and sound studio, and workshop areas and classrooms for ceramic, sculpting, painting and other hands-on art programs.

Include confirmation that the entity supports or approves to move the project forward: The City has contracted with Selser Schaefer Architects to design the Center. In addition, the City is in negotiations with Manhattan Construction for Construction Manager at Risk Services. Currently, the Architects are completing the schematic design phase.

Cost Estimate: \$4,000,000.00

Requested Vision Funding: \$1,950,000.00 (in addition to the \$650,000 already dedicated to this Center for Arts)

Proposed Schedule: Completion of Design is anticipated in January 2020 with construction starting in February or March of 2020. Time of construction is estimated to be one year, which puts end of construction March of 2021.

Project Location: The new building will be located at 300 S. Main St, at the Southwest corner of the Main Street and W. Dallas Street.
