THIS **AMENDMENT NO. 1**, made and entered into this <u>2<sup>nd</sup></u> day of <u>March</u> 2021, by and between the CITY OF BROKEN ARROW, OKLAHOMA, a municipal corporation of the State of Oklahoma, hereinafter referred to as "CITY", and LANDPLAN CONSULTANTS, LLC, hereinafter referred to as "CONSULTANT";

### WITNESSETH:

WHEREAS, CITY and CONSULTANT entered into an Agreement dated October 7, 2020 "ORIGINAL AGREEMENT" for services as set forth in said Agreement; and

**WHEREAS**, said ORIGINAL AGREEMENT requires CONSULTANT to provide design services and prepare construction documents for bidding purposes for the (project) three parking lots surrounding City Hall on each corner of First Street and Dallas Street.

**WHEREAS**, CITY and CONSULTANT propose to amend said ORIGINAL AGREEMENT to expand the project scope and compensation to include preparation of the approved concepts plans into two phases of construction documents for bidding purposes.

WHEREAS, the ORIGINAL AGREEMENT and Amendment No. 1 shall hereinafter collectively be referred to as the "Agreement"; and

WHEREAS, funding is now available for said additional services; and

WHEREAS, CONSULTANT is prepared to provide said additional services identified in this Amendment.

**NOW THEREFORE**, in consideration of the promises contained herein, the parties hereto agree to amend the Agreement as follows:

### 1. PROJECT SCOPE.

This Amendment requires CONSULTANT to provide construction documents for all three parking lots that includes lighting landscaping, and irrigation. The construction documents will be split into two separate phases in order for funding to be available for landscaping and lighting for each of the parking lots. Designing a new seat wall (brick and mortar seat walls with cast stone tops that match the aesthetics of the Rose District around the exterior of the parking lots), and

designing and bidding the project as two phases was not included in the original contract scope.

### 2. CHANGE IN CONTRACT AMOUNT.

As compensation for the additional work, CITY shall pay CONSULTANT in accordance with the terms as a change in the contract amount;

### 3. AMENDED PROJECT SCHEDULE

The schedule for Amendment No. 1 is 207 days from Notice to Proceed.

# 4. EFFECTIVE DATE AND AUTHORIZATION TO PROCEED.

This Amendment No. 1 is effective upon signature of both parties.

If CONSULTANT signs this AMENDMENT electronically and/or submits documents electronically, CONSULTANT agrees to comply with CITY'S requirements for submission of electronically signed and/or submitted documents.

Except as amended hereby, all terms of the Agreement shall remain in full force and effect without modification or change.
