# A. 24-1282 Presentation of Certificates of Recognition to Brayden Phillips and Cooper White, 8th graders at Centennial Middle School, for their achievements as members of the Broken Arrow High School Fishing Club Team.

Mayor Wimpee discussed the achievements of two young anglers from Broken Arrow, Braden Phillips and Cooper White, were recognized. Both 13 and 14 years old and members of the Broken Arrow High School Fishing Club have made significant accomplishments, including being named the 2024 Oklahoma High School Fishing Northern Junior Angler of the Year and placing as state runner-ups in the Bass Federation. They also qualified for the Bass Federation Junior World and finished 21st out of 75 teams in a recent tournament. The council members praised their achievements, noting the valuable life skills learned through fishing, such as strategy and patience, and highlighted the involvement of their families in the sport. Certificates of recognition signed by Mayor Wimpee were presented to the young anglers, who were invited to take a picture with the council.

### D. 24-1377 Presentation of a Certificate of Recognition for Broken Arrow Soccer Club's 50th Anniversary

The Broken Arrow Soccer Club is publicly recognized for its 50th Anniversary, celebrated at Indian Springs Sports Complex. The speaker highlights the club's significant contribution to the community, noting its partnership with the Parks and Recreation Department. The club serves around 2,000 players and has nearly 6,000 participants, including coaches and families. Matt Yeager, the club president, expresses gratitude for the honor and acknowledges the improvements made by the parks department over the years. A certificate of recognition is presented, commending the club for its commitment to youth soccer since 1974. Council members share personal connections to the club, emphasizing its positive impact on the community and the relationships formed through participation in soccer.

### E. 24-1388 Presentation and discussion of upcoming micro-survey about connectivity

Aaron McColloch addresses the Mayor, Vice Mayor, and council members, expressing enthusiasm for discussing a new micro survey on connectivity in Broken Arrow. This survey, focusing on pedestrian traffic, sidewalks, and trail systems, aims to improve non-motorized travel. Reflecting on a comprehensive study from January, the speaker highlights that while the community had high satisfaction with the quality of life, connectivity and mobility were areas identified for improvement.

The micro survey consists of six questions exploring perceptions of street lighting, sidewalk maintenance, and pedestrian and bicycle infrastructure. Questions ask residents about their comfort and safety walking or biking to destinations, preferences for travel modes, and desired improvements. Respondents can also specify their area for localized feedback. The survey is anonymous but asks for location details to address specific needs. Set to launch next week, it will run for three weeks to gather actionable insights.

# A. 24-1366 Consideration, discussion, and possible approval of one voting delegate and one alternate voting delegate for the National League of Cities Annual Business Meeting held on Saturday, November 16, 2024

Acting City manager Norm Stevens addresses the Mayor, Vice Mayor, and council members, discussing the upcoming National League of Cities meeting, where a designated voting delegate and alternate are required to represent the city in the annual business meeting. Historically, the Mayor, Vice Mayor, or City Manager has held the delegate position, though any official may be chosen. However, this year, the City Manager will not attend the meeting.

B. 24-1279 Consideration, discussion, and approval of and authorization to execute Agreement for Professional Consultant Services with Poe & Associates, Inc. for providing design services on the West New Orleans Street Widening from Garnett Road to Olive Avenue project (Project Number ST24200)

The Director of Engineering and Construction Charlie Bright presents a design contract for widening New Orleans Street from Olive to Garnett. This project is a critical corridor for the community, with its design funded by a 2018 bond, although construction funds were not included. The goal is to proceed with the design to begin right-of-way acquisition and utility relocation, anticipating construction funding in the next bond.

Additionally, Mr. Bright addresses the need for improvements on Garnett from 101st to 91st, a county road where the county is 95% ready to start work but faces delays due to floodplain issues. Wright notes that similar challenges will increase the cost and complexity of the city's portion. The design contract, valued at \$736,000 with Poe and Associates, reflects these complexities. Council members express eagerness for progress, emphasizing the importance of doing the work correctly to ensure safety and durability.

- C. 24-1363 Consideration, discussion, and possible award of the lowest responsible bid to Northeastern Irrigation & Landscape, Inc., and approve and authorize execution of a construction contract for the Broken Arrow Gateways Entry Signage Project (Project No. 201710)

Shannon Marshall, the Special Projects Division Manager, presents an entryway signage project for Broken Arrow that began in 2020. This initiative, part of the 2018 bond, includes four large primary signs, two more minor secondary signs, and eight fluted pole tertiary signs strategically placed at high-traffic locations to mark entry points into the city. The project aims to create a distinct identity for Broken Arrow, reinforcing its community pride and aesthetic. The contract is recommended to be awarded to the lowest bidder, Northeastern Irrigation and Landscape, for \$819,270.65. Council members express enthusiasm, emphasizing the signs' role in making Broken Arrow recognizable and enhancing its appeal. Future phases may include additional signs and potentially an iconic structure on the Broken Arrow Turnpike.

		Amanda Yamaguchi, Planning Development Manager, proposes to amend the comprehensive plan designation for a 7.5-acre undeveloped property near Kenosha Street and Aspen Avenue, changing it from Level 3 to Level 6. The site, partially plotted as Aspen Park Village and limited by a 2002 PUD to golf course use, is now proposed for a mini storage development. The applicant seeks to abrogate the current PUD and has submitted a new conceptual PUD restricted to mini-storage. Staff recommends approval, contingent on the replotted property and the new PUD gaining Council approval. The Planning Commission has already approved this change.

		Amanda Yamaguchi requested to amend the comprehensive plan for a 40-acre property from Level 6 to Level 3, supporting a proposed single-family residential subdivision. Located west of 23rd Street and north of Washington Street, this unplatted land would expand the existing Brook Chase development. The applicant submitted a rezoning request to RS4 for single- family homes and provided a preliminary plat with a conceptual layout. Staff recommends approval of this amendment, subject to platting, and the Planning Commission previously approved it with a 4-1 vote.
		Council members also discussed ongoing updates to the zoning code, which are currently being reviewed in coordination with the school district, with a committee meeting scheduled for November 20. Members noted that the zoning update would help streamline approvals and planning consistency. The project will proceed through further planning and engineering stages.
		Charlie Bright provided an update on the Washington and County Line intersection, addressing a question from the council. Initially part of a larger widening project funded by an STP grant, the project faced delays due to high drainage costs. The decision was made to focus STP funds on the intersection alone. Engineering is currently in the design scoping phase, with a design contract anticipated soon. However, due to a creek crossing at the site, the project is expected to be complex and costly, with a widened intersection likely years away.
		Council members raised concerns about adding further development in the area, given existing sewer and traffic issues, especially with upcoming projects like a new amphitheater, which may increase traffic. One council member emphasized the need to resolve sewer issues before proceeding with any new developments in the area. The council agreed to defer the discussion to a future meeting to gather more information on sewer capacity and ensure the infrastructure can support additional development.

Cindy Arnold discussed with the council the authorized solicitation of bids to sell \$23.5 million in general obligation bonds from the 2018 authorization at their regular meeting on September 17, 2024. The bids were opened today, and John Wolf will review them, with a recommendation needed from the council to accept a bid.

(John Wolf) advised the council that this morning, bids were reviewed for the sale of \$23.5 million in 20-year general obligation bonds from the 2018 authorization. Two bidders participated: BOK Financial Securities and Mesaro Financials. BOK Financial submitted the lowest bid with a genuine interest cost of 3.6161%, compared to Mesaro's 3.7594%. Given recent declines in interest rates, BOK's bid is favorable, and the recommendation is to accept it.

The bond funds are allocated for projects approved by citizens, including widening Houston (81st Street) from Lynn Lane to Highway 51, expanding Tucson Street (Aspen to the soccer complex), neighborhood street repairs, and upgrades for playgrounds in eight neighborhoods. Additional funds for street improvements are supplemented by an \$8 million sales tax revenue allocation.

G. 24-1433 Consideration, discussion, and possible action regarding COMP-001715-2024 (Comprehensive Plan Change), Gatesway Multi-Family, 35.5 acres, Level 3 and 6 to Level 3, located on one-half mile north of East Houston Street (81st Street) and one-quarter mile east of 9th Street (177th East Avenue/ Lynn Lane Road)

Amanda Yamaguchi requested to change the comprehensive plan designation from Level 2 to Level 4 for a 17-acre site half a mile north of Houston Street and a quarter mile east of 9th Street. The proposal is for a planned unit development (PUD) for multi-family housing in collaboration with the Gatesway Foundation. This request is the initial step, with rezoning and PUD applications to follow if approved. There was some confusion among council members about location details, but Ms. Yamaguchi clarified that it does not involve Albany Street, and the applicant will provide additional specifics.

A representative from the Gatesway Foundation, also a city manager in a neighboring area, addressed the council regarding a planned multi-family development on Gatesway's property in Broken Arrow. Gatesway, which has served individuals with intellectual and developmental disabilities (IDD) in the area for nearly 60 years, aims to create dignified housing for its residents and support workforce housing needs. Partnering with Beacon, a property management company, Gatesway plans to reserve 20% of the units for the population it serves, with the rest available for community members. Beacon will provide capital and manage the property, while Gatesway retains a majority interest.

Concerns about safety and vetting processes were addressed, with assurances that all tenants would undergo extensive background checks, similar to hiring standards for city staff. The project is part of Gatesway's goal to integrate its residents into the community while ensuring a safe and supportive environment. Gatesway is also enhancing its campus with community spaces and exploring ways to host events like the balloon festival.

The council raised questions about infrastructure needs, particularly the condition of College Street, but expressed overall support and appreciation for Gatesway's longstanding contributions to the community.

Shannon Tudor from Beacon discussed a commissioned traffic study for a proposed development, with results expected by November 7th. To ensure safety, the study will help identify necessary traffic improvements, such as turn lanes or lights. A council member expressed confidence in Beacon's mission and highlighted the development's benefits, including workforce housing options for teachers and first responders.

In a separate update, it was noted that there are currently no specific plans for road improvements in the area, as traffic counts are not expected to be high. However, intersections may need adjustments, such as turn lanes. Additionally, nearby access to Lynn Lane and County Line, which has been widened, is expected to help with traffic flow.

Speaking for several community members, Resident Steve Swagger expressed concerns about a proposed 180-unit apartment complex related to a comprehensive plan change. He noted potential issues, including increased traffic on College Street and nearby roads used by school

buses, potentially adding congestion and accident risks. Other concerns included the strain on local schools from an influx of children and the possibility of increased crime associated with apartment environments. However, he clarified these concerns weren't directed at any group. Swagger emphasized that while they support affordable housing, they hope it will be developed responsibly, preserving neighborhood safety and harmony.

Ben Thomas raised concerns about a proposed 180-unit apartment complex on College Street, emphasizing issues with existing infrastructure. Living on College Street, he highlighted the likely strain on the sewer system, noting his experiences with sewer line maintenance. He questioned the affordability of the planned units, pointing out that local wages might not support the \$907 monthly rent for a one-bedroom unit. Additionally, Thomas argued that College Street's narrow, worn condition is unsuitable for high-traffic apartments without significant road widening and intersection improvements. He emphasized the need to fully assess the infrastructure costs associated with adding multi-family housing in a single-family residential area.

Shannon Tudor clarified that the \$900/month rent applies to general workforce housing, not the subsidized units for Gatesway residents. This multi-family project, designed to integrate individuals with disabilities alongside other community members, involves close collaboration with the city on infrastructure, and a recent traffic study's results are pending.

City officials addressed concerns about sewer capacity, explaining a recent issue with Blue Bell Creamery's wastewater, where high flow during a concentrated time period caused overflows. A temporary solution, spreading the flow throughout 24 hours, has resolved immediate issues, and a long-term plan will reroute industrial waste directly to a main trunk line. Additionally, the city performs regular smoke tests to identify and address sewer line infiltration due to aging infrastructure, aiming to reduce excess water flow during rain events.

In summary, the proposed development includes safeguards for affordability and safety while city staff works on infrastructure improvements to support increased housing demands responsibly.

#### 12. Remarks and Inquiries by Governing Body Members

Council Member Johnnie Parks shared a personal reflection about their time working in prisons, where they noticed the absence of inmates interested in fishing or cowboy culture. They attributed this to the lack of family members or mentors to introduce these activities, such as fathers or grandfathers taking kids fishing or teaching them about ranch life. The speaker emphasized that family or close mentors are vital to fostering these interests, and they expressed joy in seeing young people engaged in such activities.
