

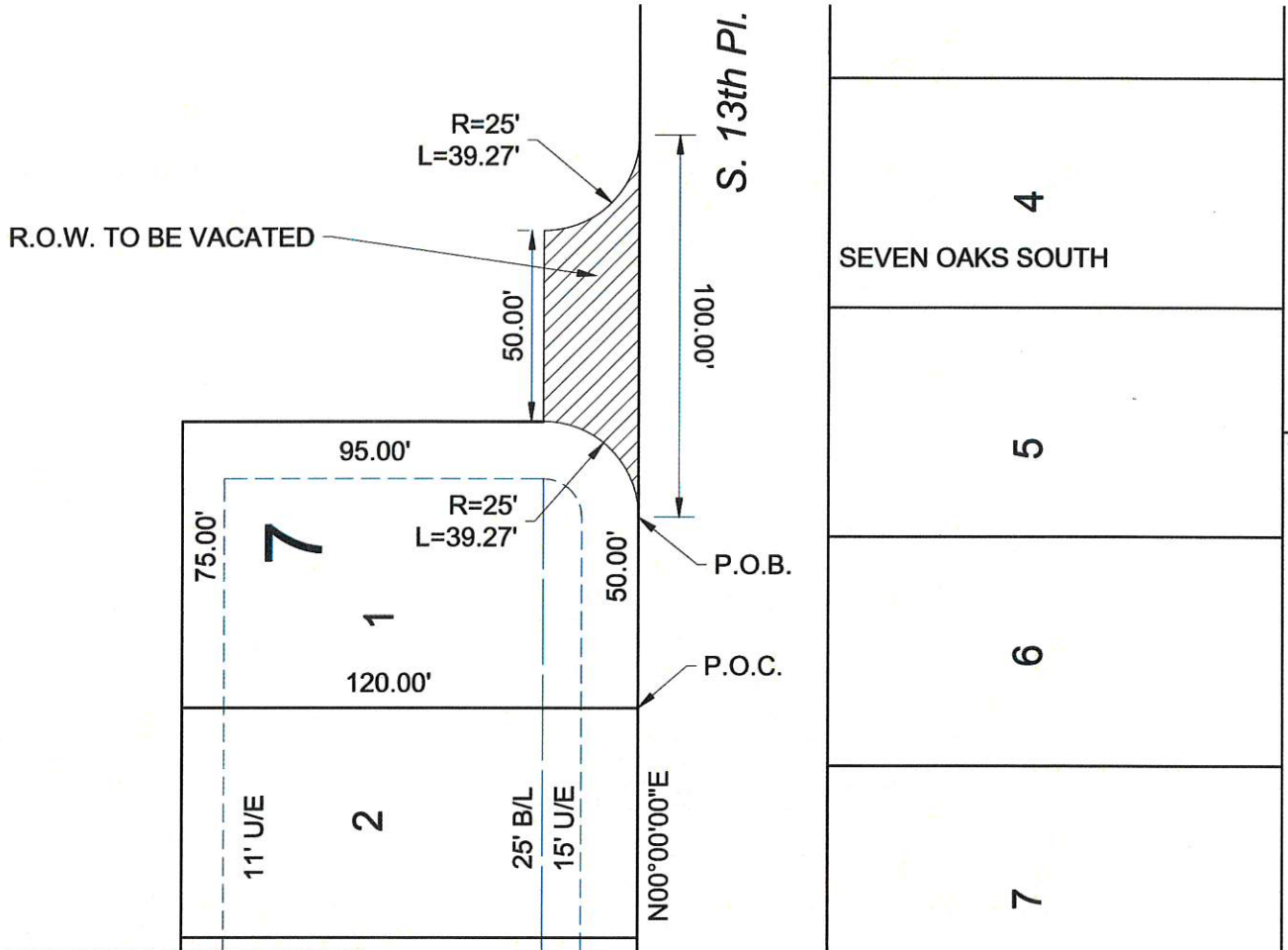
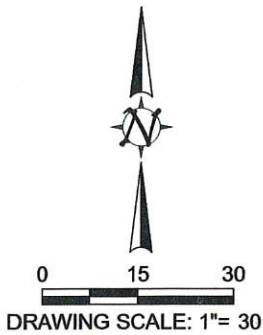
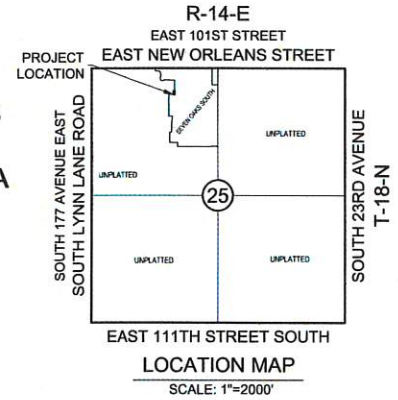

LEGAL DESCRIPTION OF PORTION TO BE VACATED

A TRACT OF LAND BEING PART OF THE PLATTED RIGHT OF WAY OF S. 13TH PL. IN SEVEN OAKS SOUTH, A SUBDIVISION IN THE CITY OF BROKEN ARROW, TULSA COUNTY, OKLAHOMA BEING PART OF SECTION TWENTY-FIVE (25), TOWNSHIP EIGHTEEN (18) NORTH, RANGE FOURTEEN (14) EAST OF THE INDIAN BASE AND MERIDIAN, BEING MORE FULLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF LOT ONE (1) BLOCK SEVEN (7) OF SAID SEVEN OAKS SOUTH; THENCE NORTH 00°00'00" EAST ALONG THE EAST LINE OF SAID LOT ONE (1) AND THE WEST RIGHT OF WAY LINE OF SOUTH 13TH PLACE, A DISTANCE OF 50.00 FEET TO A POINT OF CURVATURE ON THE EAST LINE OF SAID LOT ONE (1) AND THE POINT OF BEGINNING; THENCE ALONG SAID WEST RIGHT OF WAY LINE AND ALONG SAID CURVE TO THE LEFT HAVING A RADIUS OF 25.00 FEET, A CHORD BEARING AND DISTANCE OF NORTH 45°00'00" WEST - 35.36 FEET, FOR AN ARC LENGTH OF 39.27 FEET; THENCE CONTINUING ALONG SAID WEST RIGHT OF WAY LINE, NORTH 00°00'00" WEST, A DISTANCE OF 50.00 FEET TO A POINT OF CURVATURE; THENCE CONTINUING ALONG SAID WEST RIGHT OF WAY LINE AND ALONG SAID CURVE TO THE LEFT HAVING A RADIUS OF 25.00 FEET, A CHORD BEARING AND DISTANCE OF NORTH 45°00'00" EAST - 35.36 FEET, FOR AN ARC LENGTH OF 39.27 FEET; THENCE SOUTH 00°00'00" EAST, A DISTANCE OF 100.00 TO THE POINT OF BEGINNING.
