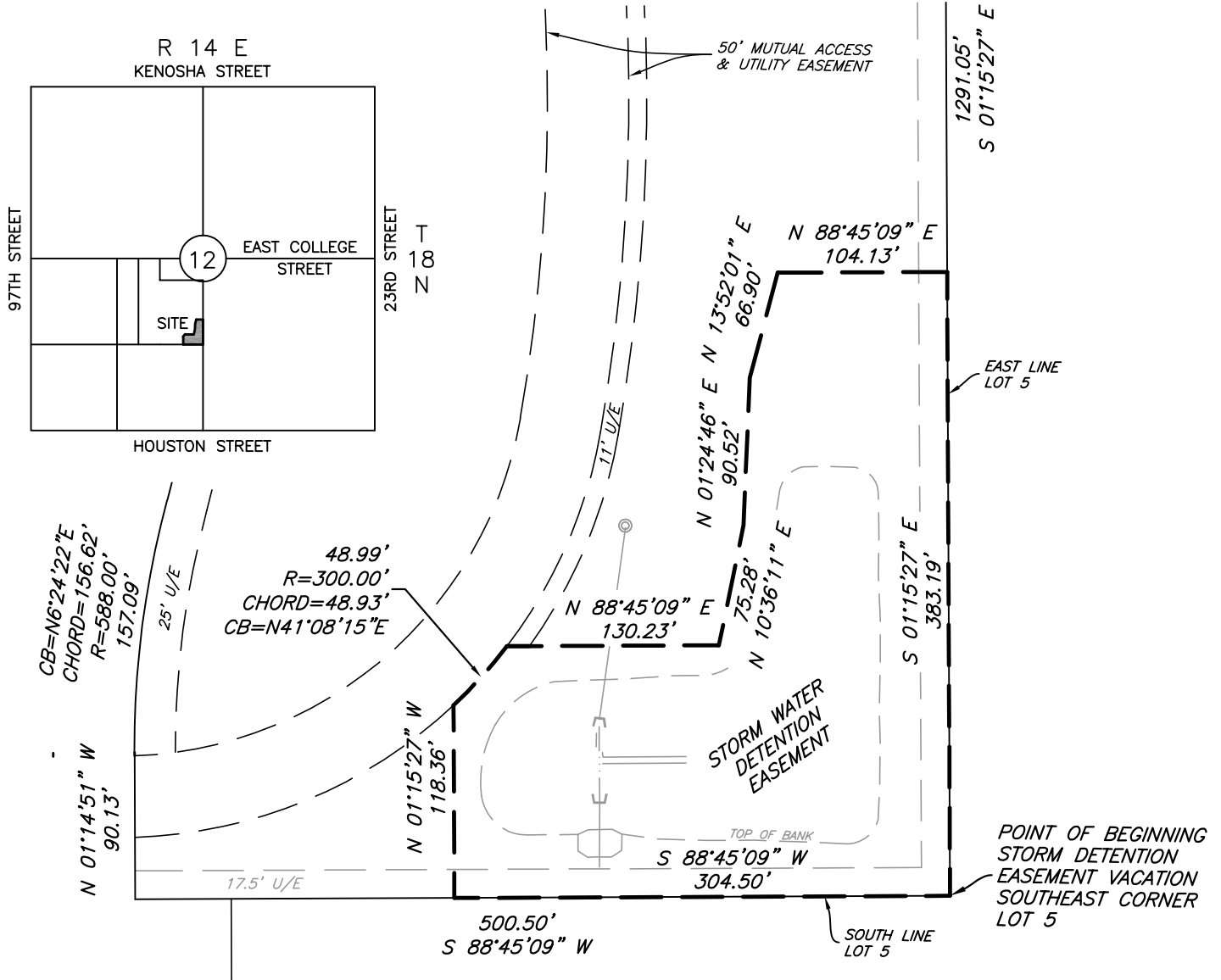

STORM DETENTION EASEMENT VACATION DESCRIPTION:

A TRACT OF LAND IN LOT FIVE (5), BLOCK ONE (1), GATESWAY FOUNDATION CAMPUS, AN ADDITION TO THE CITY OF BROKEN ARROW, TULSA COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT NO. 6406, SAID TRACT BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHEAST CORNER OF SAID LOT 5; THENCE SOUTH 89°45'09" WEST ALONG THE SOUTH LINE OF SAID LOT 5 FOR 304.50 FEET; THENCE NORTH 01°15'27" WEST FOR 118.36 FEET TO THE BEGINNING OF A NON-TANGENT CURVE TO THE LEFT; THENCE WITH SAID NON-TANGENT CURVE TO THE LEFT, HAVING A RADIUS OF 300.00 FEET, A CHORD BEARING OF NORTH 41°08'15" EAST, A CHORD DISTANCE OF 48.93 FEET, AND AN ARC LENGTH OF 48.99 FEET TO THE END OF CURVE; THENCE NORTH 88°45'09" EAST FOR 130.23 FEET; THENCE NORTH 10°36'11" EAST FOR 75.28 FEET; THENCE NORTH 01°24'46" EAST FOR 90.52 FEET; THENCE NORTH 13°52'01" EAST FOR 66.90 FEET; THENCE NORTH 88°45'09" EAST FOR 104.13 FEET TO THE EAST LINE OF SAID LOT 5; THENCE SOUTH 01°15'27" EAST ALONG SAID EAST LINE FOR 383.19 FEET TO THE POINT OF BEGINNING. CONTAINING A COMPUTED AREA OF 74,730 SQUARE FEET OR 1.72 ACRES, MORE OR LESS.
