A. 18 993 Consideration, discussion and possible directive regarding a second thirty day extension, with an option for an additional thirty day extension, to the Contract for Economic Development Services between the Broken Arrow Economic Development Authority and the Broken Arrow Economic Development Corporation

Economic Development Coordinator Norm Stevens reported the transition audit for the Broken Arrow Economic Development Corporation continued. He stated staff recommended a thirty day extension to the contract with an option for an additional thirty day extension with the approval of the City Manager. He stated contractually the City had been invoiced \$32,292 dollars per month since July 1st, 2015. He stated due to the current vacancies in the Broken Arrow Economic Development Corporation, staff met with leadership and it was agreed the \$32,292 dollars would be reduced to \$12,452 dollars during the time of the second amendment to the professional services agreement.

Council Member Parks explained, for clarification purposes, the Broken Arrow Economic Development Corporation provided economic development sourcing for the City of Broken Arrow through the Contract for Economic Development Services.
