### 5. Presentations

## 6. General Authority Business

A. 20-1219 Consideration, discussion, and possible approval of a request to provide funding to the Broken Arrow Economic Development Corporation to staff a Career / Workforce Center for eighteen months, beginning December 31, 2020 and ending July 30, 2022

Jennifer Conway, President and CEO of the Broken Arrow Chamber of Commerce, reported economic recovery was underway; however, job losses were still being experienced. She stated the Broken Arrow Economic Development Corporation was consistently assessing Broken Arrow businesses; a recent survey completed in July (with 90 businesses responding) revealed 17.86% of businesses reported trouble finding or keeping employees, and most recently more than 40% reported furloughing or laying off staff or anticipating further layoffs and furloughs. She noted the Broken Arrow unemployment rate was at 8% (which was excellent, down from 15%), but a year ago today, there was only a 3% unemployment rate. She stated combining Tulsa and Wagoner County in August 2020, 30,000 individuals were drawing unemployment benefits, and 2,500 had exhausted the benefits. She stated Broken

Arrow needed to help its citizens as it could. She stated a gap in workforce services for Broken Arrow businesses and residents had been identified. She noted currently most direct workforce services were located within the Tulsa City Limits. She stated the Chamber/EDC was proposing a virtual and physical center for intake, assessment, career counseling and referrals. She stated the Center would provide one on one skills assessment, provide upscaling and retraining opportunities, and provide in-person and virtual job fairs in Broken Arrow. She stated the Center would offer a vetted validated resource for businesses to continue economic recovery and eventual growth by locating talent and employees, providing employer recruitment support, career services, and job placement. She stated there would be no duplication of services in the region; the Center would work with existing service providers and continue to work with education partners such as Broken Arrow Public Schools, Union, Tulsa Tech, and TCC. She noted as a service center it was proposed the Center would work with a State of Oklahoma Hiring Rep, through OESC, for job identification for veterans as well. She stated possible funding included the Special CARESs Act Fund from the County which was required to be spent by December 30, 2020; this proposal had been approved and recommended by the Tulsa Economic Development Council who was managing the CARES Act Funds for Tulsa County and would go before the County Commissioners on October 12, 2020 for final approval. She stated the Chamber and EDC sought funding approval from Broken Arrow though the CARES Act in the amount of \$150,000 dollars which would pay for 1.5 employees for 18 months. She stated the EDC would seek and secure permanent funding immediately from other sources to be sure this program continued. She stated the provision of 18 months would provide a solid foundation for the program and enable the EDC to obtain additional funding sources. She noted she received an RFP yesterday where the potential business informed the EDC the workforce pipeline and services in the community was just as important as the land and the building offered. She stated for Broken Arrow to continue to grow this workforce placement program was vital. She noted the Center would be ready to open in four weeks; the virtual resources would be available sooner. She noted existing Chamber office space and the front desk area of the Public School Central Main building, would be utilized for this project. She noted this would be an excellent partnership.

City Manager Spurgeon noted the EDC was in full support of this project. He stated Broken Arrow received the CARES Act Funds and he believed the majority of the funds would go towards personnel costs related to public safety and a portion to assist with recovery from the pandemic; he stated he felt this project was an excellent use of these funds. He stated if BAEDA approved, the agreement with the EDC would be amended to outline the use of these funds, and a budget amendment would be needed to bring these funds into the budget to pay the EDC for this program. He recommended approval. He noted the Chamber and EDC were committed to raising funds to continue the program past 18 months.

Council Member Wimpee asked if there were employees lined up for this program. Ms. Conway responded in the negative; there was a job description being created; it was important for the candidate to have workforce development, career service, and HR experience, but the job description would be posted as soon as Broken Arrow and Tulsa approved. She noted buildout would be accomplished quickly as it was mostly placement of computers, desks, phones, etc.

Council Member Gillespie stated she felt this was an excellent program which would enable Broken Arrow to continue to prosper and grow.

# **Broken Arrow EDC Response to COVID-19 Pandemic**

- Continued to execute BA Rising Taskforce
  - o Taskforce continues to monitor increase in cases and opening strategy of the City of BA.
  - o Participated in video community updates to communicate current cases and strategy.
  - o Maintained <u>www.barising.com</u> which provides businesses access to PPE, opening up guidance, signage, CDC guidance and access to capital.
  - o Promoted Tulsa County and State of Oklahoma business relief grant programs.
- Fielded questions from Broken Arrow businesses directing businesses on opening directives on sanitation, funding, and labor issues as well as funding opportunities still available.



# THIRD AMENDMENT TO THE CONTRACT FOR ECONOMIC DEVELOPMENT SERVICES BETWEEN THE BROKEN ARROW ECONOMIC DEVELOPMENT AUTHORITY AND THE BROKEN ARROW ECONOMIC DEVELOPMENT CORPORATION

This Third Amendment to the Contract is made and entered into this 20<sup>th</sup> day of October, 2020, by and between the Broken Arrow Economic Development Corporation, an Oklahoma non-profit corporation, hereinafter referred to as "BAEDC," and the Broken Arrow Economic Development Authority, hereinafter referred to as "BAEDA" a public trust, whose sole beneficiary is the City of Broken Arrow.

**WHEREAS**, on December 18, 2018, BAEDC and BAEDA entered into a contract for economic development services "Agreement"; and

**WHEREAS**, on March 5, 2019, BAEDC and BAEDA entered into a First Amended Contract for the purposes of amending the amount of payment made from BAEDA to BAEDC for the employment of a full time President;

WHEREAS, the Agreement provides that BAEDA will pay BAEDC for the rendering of professional services, including but not limited to, Retail & Restaurant Development, Business Retention and Expansion, Business Attraction, Entrepreneurialism and Economic Outlook; and

**WHEREAS**, since the date of the Agreement and due to the COVID-19 pandemic, small businesses within the City of Broken Arrow have been restricted from conducting their usual and normal operations; and

WHEREAS, on May 5, 2020, the BAEDC and BAEDA entered into a Second Amended Contract for the purposes of requesting \$100,000 in additional funding from BAEDA for the funding of a Microgrant Program. This Program was designed to offer a lifeline to local small businesses which resulted in greater continuity of business operations and sustained viability during the application period for State and Federal relief programs and incentives, helping such small businesses to survive the closing of the City's economy due to the COVID-19 Pandemic;

**WHEREAS**, the BAEDC has requested \$150,000 in additional funding from BAEDA for the purpose of staffing a Career/Workforce Center for a period of eighteen months, beginning December 31, 2020 and ending June 30, 2022. This program is designed to combat the rising rate of unemployment within the City of Broken Arrow due to the COVID-19 pandemic and will offer a lifeline to citizens of the City of Broken Arrow who seek to become gainfully employed.

**NOW, THEREFORE**, in consideration of the covenants and mutual obligations set out herein and in the Agreement, as amended, and other consideration, the sufficiency of which the parties hereby acknowledge, the parties hereto hereby covenant and agree to the following Amendments:

# **ARTICLE A**

# **AMENDMENT TO AGREEMENT**

# **SECTION 5: PAYMENT AND ACTIVITY REPORTS**

A.1 Amendment to Section 5 of the Contract: Section 5, Payment and Activity Reports, is hereby amended to read in its entirety as follows:

On or before the 30<sup>th</sup> day of each month, the BAEDC shall submit to BAEDA a Monthly Activity Report detailing services and activities that accurately state the progress made in implementing the terms, conditions and scope of work required by this Contract.

That BAEDA shall pay to the BAEDC, a one-time payment in the amount of \$150,000.00 for the purpose of staffing a Career/Workforce Center for a period of eighteen months, beginning December 31, 2020 and continuing until June 30, 2022.

# **ARTICLE B**

# **CONTINUING TERMS OF AGREEMENT**

B.1 Except as amended herein, all terms of the Agreement, as amended, remains in full force and effect without modification or change. The Agreement, as amended by this Amendment, is in all respects ratified and confirmed, and the Agreement, as so amended by this Amendment, shall be read, taken and construed as one and the same instrument.
